A BILL

To amend the Wild and Scenic Rivers Act to designate segments of the Molalla River in the State of Oregon, as components of the National Wild and Scenic Rivers System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Molalla River Wild and*
 5 *Scenic Rivers Act”.*

6 **SEC. 2. DESIGNATION OF WILD AND SCENIC RIVER SEG-**
 7 **MENTS, MOLALLA RIVER, OREGON.**

8 *Section 3(a) of the Wild and Scenic Rivers Act (16*
 9 *U.S.C. 1274(a)) is amended by adding at the end the fol-*
 10 *lowing:*

11 “(_____) MOLALLA RIVER, OREGON.—

12 “(A) *The following segments in the State of*
 13 *Oregon, to be administered by the Secretary of*
 14 *the Interior as a recreational river:*

15 “(i) *The approximately 15.1-mile seg-*
 16 *ment from the southern boundary line of T.*
 17 *7 S., R. 4 E., sec. 19, downstream to the*
 18 *edge of the Bureau of Land Management*
 19 *boundary in T. 6 S., R. 3 E., sec. 7.*

20 “(ii) *The approximately 6.2-mile seg-*
 21 *ment from the easternmost Bureau of Land*
 22 *Management boundary line in the NE¹/₄*
 23 *sec. 4, T. 7 S., R. 4 E., downstream to the*
 24 *confluence with the Molalla River.*

1 “(B) *The Secretary of the Interior may not*
2 *acquire by condemnation any land or interest in*
3 *land within the boundaries of the river segments*
4 *designated by subparagraph (A).*

5 “(C) *Nothing in this paragraph—*

6 “(i) *establishes or authorizes the estab-*
7 *lishment of a protective perimeter or buffer*
8 *zone around the boundaries of the river seg-*
9 *ments designated by subparagraph (A); or*

10 “(ii) *prohibits an activity from being*
11 *conducted outside such boundaries, includ-*
12 *ing an activity that can be seen or heard*
13 *from within such boundaries.*

14 “(D) *Private or non-Federal public prop-*
15 *erty shall not be included within the boundaries*
16 *of the river segments designated by subparagraph*
17 *(A), unless the owner of that property has con-*
18 *sented in writing to having that property in-*
19 *cluded in such boundaries.”.*

20 **SEC. 3. TECHNICAL CORRECTIONS.**

21 *Section 3(a)(102) of the Wild and Scenic Rivers Act*
22 *(16 U.S.C. 1274(a)(102)) is amended—*

23 (1) *in the heading, by striking “SQUAW CREEK”*
24 *and inserting “WHYCHUS CREEK”;*

- 1 (2) *in the matter preceding subparagraph (A),*
2 *by striking “McAllister Ditch, including the Soap*
3 *Fork Squaw Creek, the North Fork, the South Fork,*
4 *the East and West Forks of Park Creek, and Park*
5 *Creek Fork” and inserting “Plainview Ditch, includ-*
6 *ing the Soap Creek, the North and South Forks of*
7 *Whychus Creek, the East and West Forks of Park*
8 *Creek, and Park Creek”;* and
9 (3) *in subparagraph (B), by striking “McAllister*
10 *Ditch” and inserting “Plainview Ditch”.*
