## A BILL

To amend the Small Business Act to establish a Veterans Business Center program, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Jobs for Veterans Act
- 5 of 2011".
- 6 SEC. 2. VETERANS BUSINESS CENTER PROGRAM.
- 7 Section 32 of the Small Business Act (15 U.S.C.
- 8 657b) is amended—

1	(1) in subsection (f), by inserting "(other than
2	subsections (g), (h), and (i))" after "this section";
3	and
4	(2) by adding at the end the following:
5	"(g) Veterans Business Center Program.—
6	"(1) In general.—The Administrator shall es-
7	tablish a Veterans Business Center program within
8	the Administration to provide entrepreneurial train-
9	ing and counseling to veterans in accordance with
10	this subsection.
11	"(2) Director and regional coordina-
12	TORS.—
13	"(A) DIRECTOR.—The Administrator shall
14	appoint a Director of the Veterans Business
15	Center program, who shall implement and over-
16	see such program and who shall report directly
17	to the Associate Administrator for Veterans
18	Business Development.
19	"(B) REGIONAL COORDINATORS.—The Di-
20	rector may appoint regional veterans business
21	center coordinators to oversee and coordinate
22	the efforts of veterans business centers.
23	"(3) Designation of Veterans Business
24	CENTERS.—The Director shall establish by regula-
25	tion an application, review, and notification process

to designate entities as veterans business centers for purposes of this section. The Director shall make publicly known the designation of an entity as a veterans business center and the award of a grant to such center under this subsection.

"(4) Funding for veterans business centers.—

"(A) Initial grants.—The Director is authorized to make a grant (hereinafter in this subsection referred to as an 'initial grant') to each veterans business center each year, for not more than 5 years, in the amount of \$200,000.

"(B) Growth funding grants.—After a veterans business center has received 5 years of initial grants under subparagraph (A), the Director is authorized to make a grant (hereinafter in this subsection referred to as a 'growth funding grant') to such center each year, for not more than 3 years, in the amount of \$150,000. After such center has received 3 years of growth funding grants, the Director shall require such center to meet performance benchmarks established by the Director to be eligible for growth funding grants in subsequent years.

1 "(5) CENTER RESPONSIBILITIES.—Each vet2 erans business center receiving a grant under this
3 subsection shall use the funds primarily on veteran
4 entrepreneurial development, counseling of veteran5 owned small businesses through one-on-one instruc6 tion and classes, and providing government procure7 ment assistance to veterans.

"(6) MATCHING FUNDS.—Each veterans business center receiving a grant under this subsection shall be required to provide a non-Federal match of 50 percent of the Federal funds such center receives under this subsection. The Director may issue to a veterans business center, upon request, a waiver of all or a portion of such matching requirement upon a determination of hardship. The Director may waive the matching funds requirement under this paragraph with respect to veterans business centers that serve communities with a per capita income that is less than 75 percent of the national per capita income and an unemployment rate that is at least 150 percent higher than the national average.

"(7) TARGETED AREAS.—The Director shall give priority to applications for designations and grants under this subsection that will establish a veterans business center in a geographic area, as de-

termined by the Director, that is not currently served by a veterans business center and in which—

3 "(A) the population of veterans exceeds the 4 national median of such measure; or

"(B) the population of veterans of Operation Enduring Freedom, Operation Iraqi Freedom, or Operation New Dawn exceeds the national median of such measure.

"(8) Training program.—The Director shall develop and implement, directly or by contract, an annual training program for the staff and personnel of designated veterans business centers to provide education, support, and information on best practices with respect to the establishment and operation of such centers. The Director shall develop such training program in consultation with veterans business centers, the interagency task force established under subsection (c), and veterans service organizations.

"(9) Inclusion of other organizations in Program.—Upon the date of the enactment of this subsection, each Veterans Business Outreach Center established by the Administrator under the authority of section 8(b)(17) and each center that received funds during fiscal year 2006 from the National

Veterans Business Development Corporation estab-2 lished under section 33 and that remains in oper-3

ation shall be treated as designated as a veterans

business center for purposes of this subsection and

5 shall be eligible for grants under this subsection.

- "(10) Rural Areas.—The Director shall submit annually to the Administrator a report on whether a sufficient percentage, as determined by the Director, of veterans in rural areas have adequate access to a veterans business center. If the Director submits a report under this paragraph that does not demonstrate that a sufficient percentage of veterans in rural areas have adequate access to a veterans business center, the Director shall give priority during the one-year period following the date of the submission of such report to applications for designations and grants under this subsection that will establish veterans business centers in rural areas.
- "(11) AUTHORIZATION OF APPROPRIATIONS.— There is authorized to be appropriated to carry out this subsection \$12,000,000 for fiscal year 2012 and \$14,000,000 for fiscal year 2013.
- 24 "(h) Additional Grants Available to Veterans
- Business Centers.—

1	"(1) Access to Capital Grant Program.—
2	"(A) IN GENERAL.—The Director of the
3	Veterans Business Center program shall estab-
4	lish a grant program under which the Director

8	"(i) Developing specialized programs
9	to assist veteran-owned small businesses to
10	secure capital and repair damaged credit.
11	"(ii) Providing informational seminars
12	on securing loans to veteran-owned small

14	"(iii) Providing one-on-one counseling

16	prove the financial presentations of such
17	businesses to lenders.
18	"(iv) Facilitating the access of vet-
19	eran-owned small businesses to both tradi-

22	"(v) Providing one-on-one or group
23	counseling to owners of small business con-
24	cerns who are members of the reserve com-
25	ponents of the Armed Forces, as specified

1	in section 10101 of title 10, United States

4	when such owners are deployed in support
5	of a contingency operation.
6	"(vi) Developing specialized programs
7	to assist unemployed veterans to become
8	entrepreneurs.
9	"(B) AWARD SIZE.—The Director may not
10	award to any one veterans business center more
11	than \$75,000 in grants under this paragraph.
12	"(C) AUTHORIZATION OF APPROPRIA-
13	TIONS.—There is authorized to be appropriated
14	to carry out this paragraph \$1,500,000 for each
15	of fiscal years 2012 and 2013.
16	"(2) Procurement assistance grant pro-

18	"(A) IN GENERAL.—The Director shall es-
19	tablish a grant program under which the Direc-
20	tor is authorized to make, to veterans business

13	with Federal regulations and bonding re-
14	quirements.
15	"(B) AWARD SIZE.—The Director may not
16	award to any one veterans business center more
17	than \$75,000 in grants under this paragraph.
18	"(C) AUTHORIZATION OF APPROPRIA-
19	TIONS.—There is authorized to be appropriated
20	to carry out this paragraph \$1,500,000 for each
21	of fiscal years 2012 and 2013.

18	TIONS.—There is authorized to be appropriated
19	to carry out this paragraph \$1,500,000 for each
20	of fiscal years 2012 and 2013.
21	"(i) Veterans Entrepreneurial Development

23	"(1) In general.—The Director of the Vet-
24	erans Business Center program is authorized to
25	carry out an event, once every 2 years, for the pur-

1	pose of providing networking opportunities, out-
2	reach, education, training, and support to veterans
3	business centers funded under this section, veteran-

5	tions, and other entities as determined appropriate
6	for inclusion by the Director. Such event shall in-

22	includes a small business owned by a surviving
23	spouse of the following:
24	"(A) A member of the Armed Forces, in-
25	cluding a reserve component thereof.

3	purposes of subsections (g), (h), and (i) the following
