RESOLUTION

Directing the Secretary of State to transmit to the House of Representatives copies of any document, record,

memo, correspondence, or other communication of the Department of State, or any portion of such communication, that refers or relates to any consultation with Congress regarding Operation Odyssey Dawn or military actions in or against Libya.

1 *Resolved*, That the House of Representatives directs
2 the Secretary of State to transmit to the House of Rep-
3 resentatives, not later than 14 days after the date of the
4 adoption of this resolution, copies of any document,
5 record, memo, correspondence, or other communication of
6 the Department of State, or any portion of such commu-
7 nication, including telephone records, electronic commu-
8 nications, email, logs and calendars, and the records of
9 internal discussions in the possession of the Secretary, or
10 any office that reports to the Secretary of State, that was
11 created on or after February 15, 2011, and refers or re-
12 lates to any of the following:

13 (1) Consultation or communication with Con-
14 gress regarding the employment or deployment of
15 the Armed Forces for Operation Odyssey Dawn or
16 military actions in or against Libya.

17 (2) The War Powers Act of 1973 and Oper-
18 ation Odyssey Dawn or military actions in or against
19 Libya.

20 *That the House of Representatives directs the Secretary of*
21 *State to transmit to the House of Representatives, not later*

1 *than 14 days after the date of the adoption of this resolu-*
2 *tion, copies of any official document, record, memo, cor-*
3 *respondence, or other communication of the Department of*
4 *State in the possession of the Secretary of State that was*
5 *created on or after February 15, 2011, and refers or relates*
6 *to any of the following:*

7 (1) *Consultation or communication with Con-*
8 *gress regarding the employment or deployment of the*
9 *United States Armed Forces for Operation Odyssey*
10 *Dawn or NATO Operation Unified Protector.*

11 (2) *The War Powers Resolution and Operation*
12 *Odyssey Dawn or Operation Unified Protector.*

Amend the title so as to read: “Resolution directing the Secretary of State to transmit to the House of Representatives copies of any official document, record, memo, correspondence, or other communication of the Department of State in the possession of the Secretary of State that refers or relates to any consultation with Congress regarding Operation Odyssey Dawn or NATO Operation Unified Protector.”.
