A BILL

To cut \$500,000,000,000 in spending in fiscal year 2011.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Cut Federal Spending
5 Act of 2011”.

6 **SEC. 2. LEGISLATIVE BRANCH.**

7 (a) IN GENERAL.—Amounts made available for fiscal
8 year 2011 for the legislative branch are reduced by
9 \$1,283,000,000.

1 (b) GOVERNMENT PRINTING OFFICE.—The Govern-
2 ment Printing Office is defunded effective on the date of
3 enactment of this Act.

4 **SEC. 3. JUDICIAL BRANCH.**

5 Amounts made available to the judicial branch for fis-
6 cal year 2011 are reduced on a pro rata basis by the
7 amount required to bring total reduction to
8 \$2,434,000,000.

9 **SEC. 4. AGRICULTURE.**

10 (a) IN GENERAL.—Including reductions made by
11 subsection (b), amounts made available to the Department
12 of Agriculture for fiscal year 2011 are reduced on a pro
13 rata basis by the amount required to bring total reduction
14 to \$42,542,000,000.

15 (b) SPECIFIC REDUCTIONS.—

16 (1) DEFUNDING.—The following agencies are
17 defunded effective on the date of enactment of this
18 Act:

19 (A) The Agriculture Research Service.

20 (B) The National Institute of Food and
21 Agriculture.

22 (C) The Resources Conservation Service.

23 (D) The Foreign Agricultural Service.

1 (2) REDUCTION.—Amounts made available to
2 the Forest Service for fiscal year 2011 are reduced
3 by \$1,178,000,000.

4 **SEC. 5. COMMERCE.**

5 (a) IN GENERAL.—Including reductions made by
6 subsection (b), amounts made available to the Department
7 of Commerce for fiscal year 2011 are reduced on a pro
8 rata basis by the amount required to bring total reduction
9 to \$5,322,000,000.

10 (b) REDUCTION.—Amounts made available to the
11 National Oceanic And Atmospheric Administration for fis-
12 cal year 2011 are reduced by \$857,000,000.

13 **SEC. 6. DEFENSE.**

14 (a) REDUCTION.—

15 (1) MILITARY PERSONNEL.—Amounts made
16 available to military personnel for fiscal year 2011
17 are reduced by \$14,000,000,000.

18 (2) PROCUREMENT.—Amounts made available
19 for procurement for fiscal year 2011 are reduced by
20 \$13,300,000,000.

21 (3) OPERATIONS AND MAINTENANCE.—
22 Amounts made available to the Operations and
23 Maintenance for fiscal year 2011 are reduced by
24 \$22,430,000,000.

1 (4) RESEARCH AND DEVELOPMENT.—Amounts
2 made available to the Research and Development for
3 fiscal year 2011 are reduced by \$8,000,000,000.

4 (5) WAR FUNDING.—Amounts made available
5 to the War funding/Overseas Contingency for fiscal
6 year 2011 are reduced by \$16,000,000,000.

7 (b) TRANSFERS.—Transfers are as follows:

8 (1) Transfer all Department of Energy ac-
9 counts to the Department of Defense (DOE capped
10 at \$17,120,000,000).

11 (2) Transfer the United States Coast Guard ac-
12 counts from the Department of Homeland Security
13 to the Department of Defense.

14 **SEC. 7. EDUCATION.**

15 All Department of Education programs are defunded
16 effective on the date of enactment of this Act, except for
17 the Pell grant program which shall be capped at
18 \$16,256,000,000.

19 **SEC. 8. ENERGY.**

20 (a) IN GENERAL.—Amounts made available to the
21 Department of Energy for fiscal year 2011 are reduced
22 by \$27,270,000,000.

23 (b) TRANSFER.—Effective on the date of enactment
24 of this Act, remaining funds and accounts for the Depart-

1 ment of Energy are transferred to the Department of De-
2 fense.

3 **SEC. 9. HEALTH AND HUMAN SERVICES.**

4 (a) IN GENERAL.—Including reductions made by
5 subsection (b), amounts not otherwise required by law
6 made available to the Department of Health and Human
7 Services for fiscal year 2011 are reduced on a pro rata
8 basis by the amount required to bring total reduction to
9 \$26,510,000,000.

10 (b) SPECIFIC REDUCTIONS.—

11 (1) FDA.—Amounts made available to the
12 Food and Drug Administration for fiscal year 2011
13 are reduced by \$230,000,000.

14 (2) HEALTH RESOURCES AND SERVICES ADMIN-
15 ISTRATION.—Amounts made available to the Health
16 Resources and Services Administration for fiscal
17 year 2011 are reduced by \$1,410,000,000.

18 (3) INDIAN HEALTH SERVICE.—Amounts made
19 available to the Indian Health Service for fiscal year
20 2011 are reduced by \$650,000,000.

21 (4) CENTER FOR DISEASE CONTROL AND PRE-
22 VENTION.—Amounts made available to the Center
23 for Disease Control and Prevention for fiscal year
24 2011 are reduced by \$1,165,000,000.

1 (5) NIH.—Amounts made available to the Na-
2 tional Institute of Health for fiscal year 2011 are re-
3 duced by \$5,825,000,000.

4 (6) SUBSTANCE ABUSE AND MENTAL HEALTH
5 SERVICE ADMINISTRATION.—Amounts made avail-
6 able to the Substance Abuse and Mental Health
7 Service Administration for fiscal year 2011 are re-
8 duced by \$626,000,000.

9 **SEC. 10. HOMELAND SECURITY.**

10 (a) IN GENERAL.—Including reductions made by
11 subsection (b), amounts made available to the Department
12 of Homeland Security for fiscal year 2011 are reduced on
13 a pro rata basis by the amount required to bring total
14 reduction to \$23,765,000,000.

15 (b) REDUCTIONS.—

16 (1) TRANSFER.—The United States Coast
17 Guard's funds and accounts are transferred to the
18 Department of Defense.

19 (2) REDUCTION.—Amounts made available to
20 the Transportation Security Administration for fis-
21 cal year 2011 are reduced by \$901,000,000.

22 **SEC. 11. HOUSING AND URBAN DEVELOPMENT.**

23 (a) DEFUNDING.—Except as provided in subsection
24 (b), all accounts and programs of the Department of

1 Housing and Urban Development are defunded effective
2 on the date of enactment of this Act.

3 (b) TRANSFER.—Effective on the date of enactment
4 of this Act, Veteran housing programs administered by the
5 Department of Housing and Urban Development are
6 transferred to Department of Veterans' Affairs.

7 **SEC. 12. INTERIOR.**

8 (a) IN GENERAL.—Including reductions made by
9 subsection (b), amounts made available to the Department
10 of Interior for fiscal year 2011 are reduced on a pro rata
11 basis by the amount required to bring total reduction to
12 \$10,934,000,000.

13 (b) REDUCTIONS.—

14 (1) LAND AND MINERAL MANAGEMENT.—
15 Amounts made available to the Land and Mineral
16 Management for fiscal year 2011 are reduced by
17 \$2,311,000,000.

18 (2) BUREAU OF RECLAMATION.—The Bureau
19 of Reclamation is defunded effective on the date of
20 enactment of this Act.

21 (3) UNITED STATES GEOLOGICAL SURVEY.—
22 Amounts made available to the United States Geo-
23 logical Survey for fiscal year 2011 are reduced by
24 \$198,000,000.

1 (4) PARK SERVICE REDUCTION.—Amounts
2 made available to the national Park Service for fiscal
3 year 2011 are reduced by \$849,000,000.

4 (5) REPEAL.—All accounts and programs of the
5 Bureau of Indian Affairs are defunded effective on
6 the date of enactment of this Act.

7 **SEC. 13. JUSTICE.**

8 (a) IN GENERAL.—Including reductions made by
9 subsection (b), amounts made available to the Department
10 of Justice for fiscal year 2011 are reduced on a pro rata
11 basis by the amount required to bring total reduction to
12 \$9,057,000,000.

13 (b) REPEAL.—All accounts and programs of the Of-
14 fice of Justice Programs are defunded effective on the date
15 of enactment of this Act.

16 **SEC. 14. LABOR.**

17 (a) IN GENERAL.—Except as provided in subsection
18 (b), amounts made available to the Department of Labor
19 for fiscal year 2011 are reduced on a pro rata basis by
20 the amount required to bring total reduction to
21 \$2,803,000,000.

22 (b) EXEMPTIONS.—The following are exempt from
23 the reductions required by subsection (a):

24 (1) The Occupational Safety and Health Ad-
25 ministration.

1 (2) The Mine Safety and Health Administra-
2 tion.

3 (3) The Employment and Training Administra-
4 tion (including all unemployment compensation).

5 **SEC. 15. STATE.**

6 (a) IN GENERAL.—Including reductions made by
7 subsection (b), amounts made available to the Department
8 of State for fiscal year 2011 are reduced on a pro rata
9 basis by the amount required to bring total reduction to
10 \$20,321,000,000.

11 (b) SPECIFIC REDUCTIONS.—The following agencies
12 are defunded effective on the date of enactment of this
13 Act:

14 (1) International Organizations and Con-
15 ferences.

16 (2) International Commissions.

17 **SEC. 16. TRANSPORTATION.**

18 (a) IN GENERAL.—Including reductions made by
19 subsection (b), amounts made available to the Department
20 of Transportation for fiscal year 2011 are reduced on a
21 pro rata basis by the amount required to bring total reduc-
22 tion to \$42,810,000,000.

23 (b) REPEAL.—Effective on the date of enactment of
24 this Act all Amtrak Federal subsidies are terminated.

1 **SEC. 17. VETERANS' AFFAIRS.**

2 The Department of Veterans' Affairs shall not be
3 subject to funding cuts in fiscal year 2011.

4 **SEC. 18. CORPS OF ENGINEERS.**

5 Amounts made available to the Corps of Engineers
6 for fiscal year 2011 are reduced on a pro rata basis by
7 the amount required to bring total reduction to
8 \$1,854,000,000.

9 **SEC. 19. ENVIRONMENTAL PROTECTION AGENCY.**

10 Amounts made available to the Environmental Pro-
11 tection Agency for fiscal year 2011 are reduced on a pro
12 rata basis by the amount required to bring total reduction
13 to \$3,238,000,000.

14 **SEC. 20. GENERAL SERVICES ADMINISTRATION.**

15 Amounts made available to the General Service Ad-
16 ministration for fiscal year 2011 are reduced on a pro rata
17 basis by the amount required to bring total reduction to
18 \$1,936,000,000.

19 **SEC. 21. NATIONAL AERONAUTICS AND SPACE ADMINIS-**
20 **TRATION.**

21 Amounts made available to the National Aeronautics
22 and Space Administration for fiscal year 2011 are reduced
23 on a pro rata basis by the amount required to bring total
24 reduction to \$4,488,000,000.

1 **SEC. 22. NATIONAL SCIENCE FOUNDATION.**

2 Amounts made available to the National Science
3 Foundation for fiscal year 2011 are reduced on a pro rata
4 basis by the amount required to bring total reduction to
5 \$4,723,000,000.

6 **SEC. 23. OFFICE OF PERSONNEL MANAGEMENT.**

7 Amounts made available to the Office of Personnel
8 Management for fiscal year 2011 are reduced on a pro
9 rata basis by the amount required to bring total reduction
10 to \$9,070,000,000.

11 **SEC. 24. SOCIAL SECURITY ADMINISTRATION.**

12 The Social Security Administration shall not be sub-
13 ject to funding cuts in fiscal year 2011.

14 **SEC. 25. REPEAL OF INDEPENDENT AGENCIES.**

15 The following agencies are defunded effective on the
16 date of enactment of this Act:

- 17 (1) Affordable Housing Program.
18 (2) Commission on Fine Arts.
19 (3) Consumer Product Safety Commission.
20 (4) Corporation for Public Broadcasting.
21 (5) National Endowment for the Arts.
22 (6) National Endowment for the Humanities.
23 (7) State Justice Institute.

24 **SEC. 26. FEDERAL COMMUNICATIONS COMMISSION.**

25 Amounts made available to the Federal Communica-
26 tion Commission for fiscal year 2011 are reduced on a

1 pro rata basis by the amount required to bring total reduc-
2 tion to \$2,150,000,000.

3 **SEC. 27. MISCELLANEOUS BUDGET SAVINGS.**

4 The following programs shall be implemented or re-
5 pealed in fiscal year 2011 with the savings provided:

6 (1) Collect delinquent taxes from Federal Em-
7 ployees, \$3,000,000,000.

8 (2) Freeze Federal Government employee pay,
9 \$2,000,000,000.

10 (3) Reduce Federal Government travel,
11 \$7,500,000,000.

12 (4) Davis- Bacon is repealed, \$6,000,000,000.

13 (5) Prohibit union labor project agreements,
14 \$2,000,000,000.

15 (6) The Troubled Assets Relief Program is re-
16 pealed, \$4,481,000,000.

17 (7) Unused Federal assets shall be sold,
18 \$19,000,000,000.

19 (8) Reduce Federal vehicle budget,
20 \$600,000,000.
