AN ACT

To prohibit attendance of an animal fighting venture, and
for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Animal Fighting Spec-
3 tator Prohibition Act of 2011”.

4 **SEC. 2. PROHIBITION ON ATTENDING AN ANIMAL FIGHT OR**
5 **CAUSING A MINOR TO ATTEND AN ANIMAL**
6 **FIGHT.**

7 Section 26 of the Animal Welfare Act (7 U.S.C.
8 2156) is amended—

9 (1) in subsection (a)—

10 (A) in the heading, by striking “SPON-
11 SORING OR EXHIBITING AN ANIMAL IN” and in-
12 sserting “SPONSORING OR EXHIBITING AN ANI-
13 MAL IN, ATTENDING, OR CAUSING A MINOR TO
14 ATTEND”;

15 (B) in paragraph (1)—

16 (i) in the heading, by striking “IN
17 GENERAL” and inserting “SPONSORING OR
18 EXHIBITING”; and

19 (ii) by striking “paragraph (2)” and
20 inserting “paragraph (3)”;

21 (C) by redesignating paragraph (2) as
22 paragraph (3); and

23 (D) by inserting after paragraph (1) the
24 following new paragraph:

25 “(2) ATTENDING OR CAUSING A MINOR TO AT-
26 TEND.—It shall be unlawful for any person to—

1 “(A) knowingly attend an animal fighting
2 venture; or

3 “(B) knowingly cause a minor to attend an
4 animal fighting venture.”; and

5 (2) in subsection (g), by adding at the end the
6 following new paragraph:

7 “(5) the term ‘minor’ means a person under the
8 age of 18 years old.”.

9 **SEC. 3. ENFORCEMENT OF ANIMAL FIGHTING PROHIBI-**
10 **TIONS.**

11 Section 49 of title 18, United States Code, is amend-
12 ed—

13 (1) by striking “Whoever” and inserting “(a)
14 IN GENERAL.—Whoever”;

15 (2) in subsection (a), as designated by para-
16 graph (1) of this section, by striking “subsection
17 (a),” and inserting “subsection (a)(1),”; and

18 (3) by adding at the end the following new sub-
19 sections:

20 “(b) ATTENDING AN ANIMAL FIGHTING VENTURE.—
21 Whoever violates subsection (a)(2)(A) of section 26 of the
22 Animal Welfare Act (7 U.S.C. 2156) shall be fined under
23 this title, imprisoned for not more than 1 year, or both,
24 for each violation.

1 “(c) CAUSING A MINOR TO ATTEND AN ANIMAL
2 FIGHTING VENTURE.—Whoever violates subsection
3 (a)(2)(B) of section 26 (7 U.S.C. 2156) of the Animal
4 Welfare Act shall be fined under this title, imprisoned for
5 not more than 3 years, or both, for each violation.”.
