A BILL

To enact President Obama's recommendations for program terminations.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the "Enacting President
5 Obama's Recommendations for Program Termination
6 Act".

7 **SEC. 2. OBAMA PROGRAM TERMINATIONS.**

8 Notwithstanding any other provision of law—

9 (1) no Federal funds may be expended for the
10 Adolescent Family Life Program of the Department
11 of Health and Human Services: *Provided*, That any

1 funds appropriated to or unobligated by the program
2 shall be rescinded and returned to the Treasury;

3 (2) no Federal funds may be expended for the
4 Agricultural, Forestry, and Fishing Program of the
5 Department of Health and Human Services: *Pro-*
6 *vided*, That any funds appropriated to or unobli-
7 gated by the program shall be rescinded and re-
8 turned to the Treasury;

9 (3) no Federal funds may be expended for the
10 B.J. Stupak Olympic Scholarship of the Department
11 of Education: *Provided*, That any funds appro-
12 priated to or unobligated by the program shall be re-
13 scinded and returned to the Treasury;

14 (4) no Federal funds may be expended for the
15 Brownfields Economic Development Initiative of the
16 Department of Housing and Urban Development:
17 *Provided*, That any funds appropriated to or unobli-
18 gated by the program shall be rescinded and re-
19 turned to the Treasury;

20 (5) no Federal funds may be expended for the

4 (84) no Federal funds may be expended for the
5 Watershed Rehabilitation Program of the Depart-
6 ment of Agriculture: *Provided*, That any funds ap-
7 propriated to or unobligated by the program shall be
8 rescinded and returned to the Treasury; and

9 (85) no Federal funds may be expended for the
10 Women's Education Equity of the Department of
11 Education: *Provided*, That any funds appropriated
12 to or unobligated by the program shall be rescinded
13 and returned to the Treasury.

14 **SEC. 3. REPEAL.**

15 Any authorization in law for a program described in
16 paragraphs (1) through (85) of section 2 shall be deemed
17 to be repealed.

○
