## A BILL

To amend title 38, United States Code, to provide that utilization of survivors' and dependents' educational assistance shall not be subject to the 48-month limitation on the aggregate amount of assistance utilizable under multiple veterans and related educational assistance programs.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. EXEMPTION OF SURVIVORS' AND DEPENDENTS'**  
2 **EDUCATIONAL ASSISTANCE FROM 48-MONTH**  
3 **LIMITATION ON AGGREGATE NUMBER OF**  
4 **MONTHS OF ASSISTANCE UTILIZABLE UNDER**  
5 **MULTIPLE VETERANS AND RELATED EDU-**  
6 **CATIONAL ASSISTANCE PROGRAMS.**

7 (a) EXEMPTION.—Section 3695(a)(4) of title 38,  
8 United States Code, is amended by striking “35,”.

9 (b) APPLICABILITY.—The amendment made by sub-  
10 section (a) shall take effect on the date of the enactment  
11 of this Act, and shall not operate to revive any entitlement  
12 to assistance under chapter 35 of title 38, United States  
13 Code, or the provisions of law referred to in section  
14 3695(a) of such title, as in effect on the day before such  
15 date, that was terminated by reason of the operation of  
16 section 3695(a) of such title, as so in effect, before such  
17 date.

18 (c) REVIVAL OF ENTITLEMENT REDUCED BY PRIOR  
19 UTILIZATION OF CHAPTER 35 ASSISTANCE.—In the case  
20 of an individual whose period of entitlement to assistance  
21 under a provision of law referred to in section 3695(a)  
22 of title 38, United States Code (other than chapter 35 of  
23 such title), as in effect on the day before the date of the  
24 enactment of this Act, was reduced under such section  
25 3695(a), as so in effect, by reason of the utilization of  
26 entitlement to assistance under chapter 35 of such title

1 before the date of the enactment of this Act, the period  
2 of entitlement to assistance of such individual under such  
3 provision shall be determined without regard to any enti-  
4 tlement so utilized by the individual under chapter 35 of  
5 such title.
