A BILL

To limit the use of cluster munitions.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Cluster Munitions Ci-
5 vilian Protection Act of 2011”.

6 **SEC. 2. LIMITATION ON THE USE OF CLUSTER MUNITIONS.**

7 No funds appropriated or otherwise available to any
8 Federal department or agency may be obligated or ex-
9 pended to use any cluster munitions unless—

1 (1) the submunitions of the cluster munitions,
2 after arming, do not result in more than 1 percent
3 unexploded ordnance across the range of intended
4 operational environments; and

5 (2) the policy applicable to the use of such clus-
6 ter munitions specifies that the cluster munitions
7 will only be used against clearly defined military tar-
8 gets and will not be used where civilians are known
9 to be present or in areas normally inhabited by civil-
10 ians.

11 **SEC. 3. PRESIDENTIAL WAIVER.**

12 The President may waive the requirement under sec-
13 tion 2(1) if, prior to the use of cluster munitions, the
14 President—

15 (1) certifies that it is vital to protect the secu-
16 rity of the United States; and

17 (2) not later than 30 days after making such
18 certification, submits to the appropriate congres-
19 sional committees a report, in classified form if nec-
20 essary, describing in detail—

21 (A) the steps that will be taken to protect
22 civilians; and

23 (B) the failure rate of the cluster muni-
24 tions that will be used and whether such muni-

1 tions are fitted with self-destruct or self-deacti-
2 vation devices.

3 **SEC. 4. CLEANUP PLAN.**

4 Not later than 90 days after any cluster munitions
5 are used by a Federal department or agency, the President
6 shall submit to the appropriate congressional committees
7 a plan, prepared by such Federal department or agency,
8 for cleaning up any such cluster munitions and submuni-
9 tions which fail to explode and continue to pose a hazard
10 to civilians.

11 **SEC. 5. APPROPRIATE CONGRESSIONAL COMMITTEES DE-**
12 **FINED.**

13 In this Act, the term “appropriate congressional com-
14 mittees” means the Committee on Foreign Relations, the
15 Committee on Armed Services, and the Committee on Ap-
16 propriations of the Senate and the Committee on Foreign
17 Affairs, the Committee on Armed Services, and the Com-
18 mittee on Appropriations of the House of Representatives.
