## A BILL

To reauthorize the Federal Land Transaction Facilitation Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Federal Land Trans-  
5 action Facilitation Act Reauthorization of 2011”.

1 **SEC. 2. FEDERAL LAND TRANSACTION FACILITATION ACT.**

2 The Federal Land Transaction Facilitation Act is  
3 amended—

4 (1) in section 203(2) (43 U.S.C. 2302(2)), by  
5 striking “on the date of enactment of this Act was”  
6 and inserting “is”;

7 (2) in section 205 (43 U.S.C. 2304)—

8 (A) in subsection (a), by striking “this  
9 Act” and inserting “the Federal Land Trans-  
10 action Facilitation Act Reauthorization of ~~2009~~  
11 *2011*”; and

12 (B) in subsection (d), by striking “11” and  
13 inserting “21”;

14 (3) in section 206 (43 U.S.C. 2305), by striking  
15 subsection (f); and

16 (4) in section 207(b) (43 U.S.C. 2306(b))—

17 (A) in paragraph (1)—

18 (i) by striking “96–568” and insert-  
19 ing “96–586”; and

20 (ii) by striking “; or” and inserting a  
21 semicolon;

22 (B) in paragraph (2)—

23 (i) by inserting “Public Law 105–  
24 263;” before “112 Stat.”; and

25 (ii) by striking the period at the end  
26 and inserting a semicolon; and

1 (C) by adding at the end the following:

2 “(3) the White Pine County Conservation,  
3 Recreation, and Development Act of 2006 (Public  
4 Law 109–432; 120 Stat. 3028);

5 “(4) the Lincoln County Conservation, Recre-  
6 ation, and Development Act of 2004 (Public Law  
7 108–424; 118 Stat. 2403);

8 “(5) subtitle F of title I of the Omnibus Public  
9 Land Management Act of 2009 (16 U.S.C. 1132  
10 note; Public Law 111–11);

11 “(6) subtitle O of title I of the Omnibus Public  
12 Land Management Act of 2009 (16 U.S.C. 460www  
13 note, 1132 note; Public Law 111–11);

14 “(7) section 2601 of the Omnibus Public Land  
15 Management Act of 2009 (Public Law 111–11; 123  
16 Stat. 1108); or

17 “(8) section 2606 of the Omnibus Public Land  
18 Management Act of 2009 (Public Law 111–11; 123  
19 Stat. 1121).”.
