Mr. CASEY introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To amend the Harmonized Tariff Schedule of the United States to make a technical correction relating to stainless steel single-piece exhaust gas manifolds.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TECHNICAL CORRECTION RELATING TO STAIN-**
4 **LESS STEEL SINGLE-PIECE EXHAUST GAS**
5 **MANIFOLDS.**

6 (a) STAINLESS STEEL SINGLE-PIECE EXHAUST GAS
7 MANIFOLDS.—Heading 9902.40.94 of the Harmonized
8 Tariff Schedule of the United States is amended in the

1 article description by striking “9902.01.50” and inserting
2 “8409.91.50”.

3 (b) EFFECTIVE DATE.—

4 (1) IN GENERAL.—The amendment made by
5 this section applies to goods entered, or withdrawn
6 from warehouse for consumption, on or after the
7 15th day after the date of the enactment of this Act.

8 (2) RETROACTIVE APPLICABILITY.—

9 (A) IN GENERAL.—Notwithstanding sec-
10 tion 514 of the Tariff Act of 1930 (19 U.S.C.
11 1514) or any other provision of law and subject
12 to subparagraph (B), the entry of a good de-
13 scribed in heading 9902.40.94 of the Har-
14 monized Tariff Schedule of the United States
15 (as amended by this section)—

16 (i) which was made on or after Janu-
17 ary 1, 2010, and before the 15th day after
18 the date of the enactment of this Act, and

19 (ii) with respect to which there would
20 have been no duty or a reduced duty (as
21 the case may be) if the amendment made
22 by this section applied to such entry,
23 shall be liquidated or reliquidated as though the
24 entry had been made on the 15th day after the
25 date of the enactment of this Act.

1 (B) REQUESTS.—A liquidation or reliqui-
2 dation may be made under subparagraph (A)
3 with respect to an entry only if a request there-
4 for is filed with U.S. Customs and Border Pro-
5 tection not later than 180 days after the date
6 of the enactment of this Act that contains suffi-
7 cient information to enable U.S. Customs and
8 Border Protection—

9 (i) to locate the entry; or

10 (ii) to reconstruct the entry if it can-
11 not be located.

12 (C) PAYMENT OF AMOUNTS OWED.—Any
13 amounts owed by the United States pursuant to
14 the liquidation or reliquidation of an entry of a
15 good under subparagraph (A) shall be paid,
16 without interest, not later than 90 days after
17 the date of the liquidation or reliquidation (as
18 the case may be).

19 (D) DEFINITION.—As used in this para-
20 graph, the term “entry” includes a withdrawal
21 from warehouse for consumption.
