**A BILL**

To amend the Public Health Service Act to reauthorize the program of payments to children's hospitals that operate graduate medical education programs.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Children’s Hospital  
3 GME Support Reauthorization Act of 2011”.

4 **SEC. 2. PROGRAM OF PAYMENTS TO CHILDREN’S HOS-**  
5 **PITALS THAT OPERATE GRADUATE MEDICAL**  
6 **EDUCATION PROGRAMS.**

7 Section 340E of the Public Health Service Act (42  
8 U.S.C. 256e) is amended—

9 (1) in subsection (a), by striking “2011” and  
10 inserting “2016”;

11 (2) in subsection (b)(3)(D)—

12 (A) in the heading, by striking “REPORT”  
13 and inserting “REPORTS”; and

14 (B) in the matter preceding clause (i), by  
15 inserting “and not later than the end of fiscal  
16 year 2015,” after “2011,”; and

17 (3) in subsection (f)—

18 (A) in paragraph (1)(A)(iv), by striking  
19 “2011” and inserting “2016”; and

20 (B) in paragraph (2)(D), by striking  
21 “2011” and inserting “2016”.
