## RESOLUTION

Authorizing expenditures by committees of the Senate for the periods March 1, 2011, through September 30, 2011, and October 1, 2011, through September 30, 2012, and October 1, 2012, through February 28, 2013.

1       *Resolved,*

2       **SECTION 1. AGGREGATE AUTHORIZATION.**

3       (a) IN GENERAL.—For purposes of carrying out the  
4 powers, duties, and functions under the Standing Rules  
5 of the Senate, and under the appropriate authorizing reso-  
6 lutions of the Senate there is authorized for the period  
7 March 1, 2011, through September 30, 2011, in the ag-

1 gregate of \$70,790,674, for the period October 1, 2011,  
2 through September 30, 2012, in the aggregate of  
3 \$121,355,435, and for the period October 1, 2012,  
4 through February 28, 2013, in the aggregate of  
5 \$50,564,763, in accordance with the provisions of this res-  
6 olution, for standing committees of the Senate, the Special  
7 Committee on Aging, the Select Committee on Intel-  
8 ligence, and the Committee on Indian Affairs.

9 (b) AGENCY CONTRIBUTIONS.—There are authorized  
10 such sums as may be necessary for agency contributions  
11 related to the compensation of employees of the commit-  
12 tees for the period March 1, 2011, through September 30,  
13 2011, for the period October 1, 2011, through September  
14 30, 2012, and for the period October 1, 2012, through  
15 February 28, 2013, to be paid from the appropriations  
16 account for “Expenses of Inquiries and Investigations” of  
17 the Senate.

18 **SEC. 2. COMMITTEE ON AGRICULTURE, NUTRITION, AND**  
19 **FORESTRY.**

8 department or agency concerned and the Committee  
9 on Rules and Administration, to use on a reimburs-  
10 able, or nonreimbursable, basis the services of per-  
11 sonnel of any such department or agency.

21 (2) not to exceed \$40,000, may be expended for  
22 the training of the professional staff of such com-  
23 mittee (under procedures specified by section 202(j)  
24 of that Act).

1 (c) EXPENSES FOR FISCAL YEAR 2012 PERIOD.—

10 (2) not to exceed \$40,000, may be expended for

12 mittee (under procedures specified by section 202(j)

1           (b) AVAILABILITY.—The special reserve authorized in

6 of subsection (a); and

7           (2) at the request of a Chairman and Ranking  
8 Member of that committee subject to the approval of  
9 the Chairman and Ranking Member of the Com-
