Mr. GRIFFITH (for himself, Mrs. BEATTY, Mr. SENSENBRENNER, Mr. HARPER, Mr. THOMPSON of California, and Mr. DAVID SCOTT of Georgia) introduced the following bill; which was referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To amend title XVIII of the Social Security Act to expand access to stroke telehealth services under the Medicare program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Furthering Access to
5 Stroke Telemedicine Act” or the “FAST Act”.

1 **SEC. 2. EXPANDING ACCESS TO STROKE TELEHEALTH**
2 **SERVICES UNDER THE MEDICARE PROGRAM.**

3 (a) **IN GENERAL.**—Section 1834(m)(4)(C) of the So-
4 cial Security Act (42 U.S.C. 1395m(m)(4)(C)) is amend-
5 ed—

6 (1) in clause (i), by striking “The term” and
7 inserting “Subject to clause (iii), the term”; and

8 (2) by adding at the end the following new
9 clause:

10 “(iii) **STROKE TELEHEALTH SERV-**
11 **ICES.**—With respect to services related to
12 the evaluation or treatment of an acute
13 stroke that are provided within the evi-
14 dence-based window of treatment, the term
15 ‘originating site’ means any site at which
16 the eligible telehealth individual is located
17 at the time the service is furnished via a
18 telecommunications system, regardless of
19 where the site is located.”.

20 (b) **NO ORIGINATING SITE FACILITY FEE FOR NEW**
21 **SITES.**—Section 1834(m)(2)(B) of the Social Security Act
22 (42 U.S.C. 1395m(m)(2)(B)) is amended, in the matter
23 preceding clause (i), by inserting “(other than an origi-
24 nating site that is only described in clause (iii) of para-
25 graph (4)(C), and does not meet the requirement for an

1 originating site under clause (i) of such paragraph)” after
2 “the originating site”.

3 (c) EFFECTIVE DATE.—The amendments made by
4 this section shall apply to services furnished on or after
5 the date that is 1 year after the date of the enactment
6 of this Act.
