Mr. MARKEY (for himself, Mr. FRANKEN, Mrs. FEINSTEIN, Mrs. SHAHEEN, Mr. MERKLEY, Ms. WARREN, Mrs. BOXER, and Mr. MENENDEZ) introduced the following bill; which was read twice and referred to the Committee on Commerce, Science, and Transportation

A BILL

To authorize the National Oceanic and Atmospheric Administration to establish a Climate Change Education Program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Climate Change Edu-
5 cation Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds that—

8 (1) the evidence for human-induced climate
9 change is overwhelming and undeniable;

1 (2) the United States is the second highest
2 emitter of carbon dioxide and other greenhouse
3 gases in the world;

4 (3) atmospheric carbon can be significantly re-
5 duced through conservation, by shifting to renewable
6 energy sources such as solar, wind, tidal, and geo-
7 thermal, and by increasing the efficiency of build-
8 ings, including domiciles, and transportation;

9 (4) providing clear information about climate
10 change, in a variety of forms, can remove the fear
11 and the sense of helplessness, and encourage individ-
12 uals and communities to take action;

13 (5) implementation of measures that promote
14 energy efficiency, conservation, and renewable en-
15 ergy will greatly reduce human impact on the envi-
16 ronment; and

17 (6) informing people of new technologies and
18 programs as they become available will ensure max-
19 imum understanding and maximum impact of those
20 measures.

21 **SEC. 3. DEFINITION.**

22 In this Act, the term “climate change education”
23 means informal and formal interdisciplinary learning at
24 all age levels about climate change and its effects on envi-
25 ronmental, energy, social, and economic systems.

1 **SEC. 4. CLIMATE CHANGE EDUCATION PROGRAM.**

2 The National Oceanic and Atmospheric Administra-
3 tion shall establish a Climate Change Education Program
4 to—

5 (1) broaden the understanding of human-in-
6 duced climate change, possible long-term and short-
7 term consequences, and potential solutions;

8 (2) apply the latest scientific and technological
9 discoveries to provide formal and informal learning
10 opportunities to people of all ages, including those of
11 diverse cultural and linguistic backgrounds;

12 (3) emphasize actionable information to help
13 people understand and to promote implementation of
14 new technologies, programs, and incentives related
15 to energy conservation, renewable energy, and green-
16 house gas reduction; and

17 (4) inform the public of impacts to human
18 health and safety as a result of climate change.

19 **SEC. 5. PROGRAM ELEMENTS.**

20 The Climate Change Education Program shall in-
21 clude—

22 (1) a national information campaign to dissemi-
23 nate information on and promote implementation of
24 the new technologies, programs, and incentives de-
25 scribed in section 4(3); and

26 (2) the grant program described in section 6.

1 **SEC. 6. GRANT PROGRAM.**

2 The National Oceanic and Atmospheric Administra-
3 tion shall establish a program to make grants—

4 (1) to support national public education, out-
5 reach, and communication programs to engage sub-
6 stantial numbers of the public in understanding cli-
7 mate change while developing educated and empow-
8 ered consumers, investors, and citizens;

9 (2) to encourage and support statewide plans
10 and programs for climate change education, includ-
11 ing relevant teacher training and professional devel-
12 opment, STEM (science, technology, engineering,
13 and mathematics) education, and multidisciplinary
14 studies to ensure that students graduate from high
15 school climate literate, with a particular focus on
16 programs that advance widespread State and local
17 educational agency adoption of climate change edu-
18 cation, including funding for State education agen-
19 cies to—

20 (A) integrate key principles of climate
21 change education into existing K–12 State aca-
22 demic content standards, student academic
23 achievement standards, or State curriculum
24 frameworks;

25 (B) create model State climate change cur-
26 ricula; or

1 (C) create State green school building
2 standards or policies;

3 (3) to improve the quality of and access to
4 higher education in green collar industries and green
5 economy-related fields such as green business, tech-
6 nology, engineering, policy studies, and sustainability
7 science, with a particular focus on programs that ad-
8 dress restructuring institutional incentives and re-
9 ducing institutional barriers to widespread faculty
10 adoption of interdisciplinary teaching of climate
11 change education;

12 (4) for institutions of higher education to en-
13 gage teams of faculty and students to develop ap-
14 plied climate research and deliver to local commu-
15 nities direct services on climate mitigation and adap-
16 tation issues impacting such communities, with a
17 priority on distressed communities; and

18 (5) for projects that build capacity for climate
19 adaptation at the State and national level includ-
20 ing—

21 (A) career education;

22 (B) expanding green collar workforce
23 training;

24 (C) secondary school preparation or work-
25 based experiences in green collar fields; and

1 (D) continuing education needed for prac-
2 ticing professionals for green economy-related
3 fields.

4 **SEC. 7. REPORT TO CONGRESS.**

5 Not later than 1 year after the date of enactment
6 of this Act, and annually thereafter, the National Oceanic
7 and Atmospheric Administration shall transmit to Con-
8 gress a report that evaluates the scientific merits, edu-
9 cational effectiveness, and broader impacts of activities
10 under this Act.

11 **SEC. 8. AUTHORIZATION OF APPROPRIATIONS.**

12 There are authorized to be appropriated to the Na-
13 tional Oceanic and Atmospheric Administration
14 \$20,000,000 for each of fiscal years 2017 through 2021
15 for carrying out this Act.
