A BILL

To increase the Federal share provided under the Robert T. Stafford Disaster Relief and Emergency Assistance Act for a certain time frame during fiscal year 2020.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SEC. 1. SHORT TITLE.**

4 *This Act may be cited as the “Increase Federal Dis-*
 5 *aster Cost Share Act of 2021”.*

6 **SEC. 2. INCREASE OF FEDERAL SHARE.**

7 *Notwithstanding sections 403(b), 403(c)(4), 404(a),*
 8 *406(b), 408(d), 408(g)(2), 428(e)(2)(B), and 503(a) of the*
 9 *Robert T. Stafford Disaster Relief and Emergency Assist-*
 10 *ance Act 10 (42 U.S.C. 5121 et seq.), for any major disaster*
 11 *declared by the President under such Act during the period*
 12 *beginning on January 1, 2020, and ending on December*
 13 *31, 2020, the Federal share of assistance provided under*
 14 *such sections shall be not less than 90 percent of the eligible*
 15 *cost of such assistance.*

Amend the title so as to read: “A bill to increase the Federal share provided under the Robert T. Stafford Disaster Relief and Emergency Assistance Act for a certain time frame during 2020.”.
