A BILL

To revise the boundary of the Ste. Genevieve National Historical Park in the State of Missouri, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Ste. Genevieve Na-
 5 tional Historical Park Boundary Revision Act”.

6 **SEC. 2. STE. GENEVIEVE NATIONAL HISTORICAL PARK**
 7 **BOUNDARY REVISION.**

8 (a) MAP.—Section 7134(a)(3) of appendix C of the
 9 Consolidated Appropriations Act, 2018 (16 U.S.C.
 10 410xxx(a)(3)), is amended by striking “numbered 571/
 11 149,942, and dated December 2018” and inserting “num-
 12 bered 571/177,464, and dated September 2021”.

13 (b) AUTHORITY TO CORRECT ERRORS IN MAP.—Sec-
 14 tion 7134(d) of appendix C of the Consolidated Appropria-
 15 tions Act, 2018 (16 U.S.C. 410xxx(d)), is amended—

16 (1) by striking “The Map” and inserting the
 17 following:

18 “(1) IN GENERAL.—The Map”; and

19 (2) by adding at the end the following:

20 “(2) AUTHORITY TO CORRECT ERRORS.—The
 21 Secretary may correct any clerical or typographical
 22 errors in the Map.”.

23 (c) VISITOR CENTER.—Section 7134(e) of appendix
 24 C of the Consolidated Appropriations Act, 2018 (16

1 U.S.C. 410xxx(e)), is amended by adding at the end the
2 following:

3 “(3) VISITOR CENTER.—The Secretary—

4 “(A) may acquire, by donation, the land
5 (including any improvements to the land)
6 owned by the city of Ste. Genevieve, Missouri,
7 and used as the visitor center for the Historical
8 Park, as generally depicted on the Map as ‘Pro-
9 posed Boundary Addition’; and

10 “(B) on acquisition of the land described
11 in subparagraph (A), shall revise the boundary
12 of the Historical Park to include the acquired
13 land.”.
