Mrs. GREENE of Georgia (for herself, Mr. HARRIS, and Mrs. MILLER of Illinois) introduced the following bill; which was referred to the Committee on the Judiciary

## A BILL

To deem certain conduct of members of the groups “Jane’s Revenge” and “Ruth Sent Us” as domestic terrorism, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting Mothers  
5 and Babies from Terrorism Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

8 (1) On May 8, 2022, the headquarters of Wis-  
9 consin Family Action, a pregnancy center in Madi-

1 son, Wisconsin, was set on fire and left with graffiti  
2 saying, “If abortions aren’t safe then you aren’t ei-  
3 ther”, with “Jane’s Revenge” claiming responsibility  
4 for the attack and for several other similar attacks  
5 across the country.

6 (2) On May 25, 2022, Next Step Pregnancy  
7 Center in Lynnwood, Washington, was vandalized  
8 and graffitied.

9 (3) On May 22, 2022, St. Michael’s Parish in  
10 Olympia, Washington, was vandalized with the  
11 words “Abort the church” spray-painted on the wall,  
12 with “Jane’s Revenge” claiming responsibility.

13 (4) In May 2022, graffiti saying, “Not a Clin-  
14 ic” and “From Jane” was found at Dove Medical  
15 Clinic in Eugene, Oregon.

16 (5) In May 2022, the offices of Oregon Right  
17 to Life in Keizer, Oregon, were set on fire.

18 (6) In May 2022, the windows of Southeast  
19 Portland Pregnancy Resource Center in Portland,  
20 Oregon, were smashed and a hateful message was  
21 spray-painted on the wall.

22 (7) On June 10, 2022, a fire was set to Gresh-  
23 am Pregnancy Resource Center in Gresham, Oregon.

1           (8) In June 2022, graffiti saying, “Jane’s Re-  
2           venge” was found on the walls of Options360 Wom-  
3           en’s Clinic in Vancouver, Washington.

4           (9) On June 2, 2022, vandalism occurred at  
5           Community Pregnancy Center in Anchorage, Alaska.

6           (10) On May 3, 2022, Sacred Heart of Mary  
7           Parish in Boulder, Colorado, was attacked with graf-  
8           fiti and windows were smashed.

9           (11) On May 7, 2022, St. John XXIII Parish  
10          in Fort Collins, Colorado, was attacked with graffiti  
11          and windows were smashed.

12          (12) On the weekend of May 7, 2022, Woman  
13          to Woman Resource Center and Loreto House in  
14          Denton, Texas, were vandalized and graffitied.

15          (13) On May 3, 2022, Trotter House, a preg-  
16          nancy center in Austin, Texas, was attacked and  
17          vandalized.

18          (14) In May 2022, Holy Rosary Catholic  
19          Church in Houston, Texas, was graffitied.

20          (15) In May 2022, South Broward Pregnancy  
21          Center in Hollywood, Florida, was sprayed with  
22          graffiti including, “Janes revenge” with an anarchist  
23          symbol.

24          (16) In June 2022, Mountain Area Pregnancy  
25          Services in Asheville, North Carolina, had its win-

1 dows smashed in with graffiti spray-painted on the  
2 walls.

3 (17) In June 2022, CompassCare, a pregnancy  
4 center in Amherst, New York, sustained major fire  
5 damage, broken windows, and graffiti saying, “Jane  
6 was here”.

7 (18) On June 11, 2022, Hope Pregnancy Cen-  
8 ter in Philadelphia, Pennsylvania, sustained smashed  
9 glass doors and windows and vandalism.

10 (19) On June 3, 2022, Capitol Hill Pregnancy  
11 Center in Washington, DC, was vandalized with  
12 graffiti saying, “Jane says revenge”.

13 (20) In May 2022, a far-left extremist damaged  
14 and urinated on the office of Concerned Women for  
15 America in Alexandria, Virginia.

16 (21) On May 7, 2022, First Care Women’s  
17 Health in Manassas, Virginia, was vandalized with  
18 spray paint.

19 **SEC. 3. DESIGNATION.**

20 The conduct of members of the groups “Jane’s Re-  
21 venge” and “Ruth Sent Us” described in section 2 is  
22 deemed to be domestic terrorism (as such term is defined  
23 in section 2331 of title 18, United States Code).
