## A BILL

To prohibit any employee or contractor of U.S. Immigration and Customs Enforcement or the Department of Health and Human Services from transporting any alien across State lines for the purpose of procuring an abortion for such alien.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “No Taxpayer Funds  
3 for Illegal Alien Abortions Act”.

4 **SEC. 2. RESTRICTION ON THE TRANSPORTATION OF**  
5 **ALIENS.**

6 Notwithstanding any other provision of law, an em-  
7 ployee or contractor of U.S. Immigration and Customs  
8 Enforcement or the Department of Health and Human  
9 Services, acting within the scope of the individual’s em-  
10 ployment or contract, may not transport, or arrange for  
11 the transportation of, any alien who is unlawfully present  
12 in the United States across any State line for the purpose  
13 of procuring an abortion for such alien.

14 **SEC. 3. LIMITATIONS ON THE USE OF FEDERAL FUNDS FOR**  
15 **ABORTIONS.**

16 No funds authorized or appropriated by Federal law  
17 for U.S. Immigration and Customs Enforcement or for the  
18 Department of Health and Human Services may be used  
19 or made available—

20 (1) to pay for an abortion, except in instances  
21 in which—

22 (A) the life of the mother would be endan-  
23 gered if the fetus were carried to term; or

24 (B) the pregnancy was the result of rape  
25 or incest; or

1           (2) to require any person to perform, or to fa-  
2           cilitate in any way the performance of, any abortion.
