15 School Administrators, Board Members, Teachers,
16 and Staff”’.

8 (1) *The Memorandum issued by Attorney Gen-*
9 *eral Merrick Garland, dated October 4, 2021, entitled*
10 *“Partnership Among Federal, State, Local, Tribal,*
11 *and Territorial Law Enforcement to Address Threats*
12 *Against School Administrators, Board Members,*
13 *Teachers, and Staff”.*

14 (2) *Communication or coordination between the*
15 *Executive Office of the President and the Department*
16 *of Justice regarding the Attorney General’s Memo-*
17 *randum, dated October 4, 2021.*

18 (3) *Communication or coordination between the*
19 *Executive Office of the President and the Department*
20 *of Justice regarding threats at or towards schools,*
21 *school boards, universities, or other public educational*
22 *institutions and their employees inspired by violent*
23 *white extremism, misogynistic extremism, far-right*
24 *extremism, or anti-government extremism, including*

1 *the Mesquite Elementary School kidnapping plot and*
 2 *the Oxford High School shooting.*

3 *(4) Communication or coordination between the*
 4 *Executive Office of the President and the Department*
 5 *of Justice regarding threats at or towards the admin-*
 6 *istrators, board members, teachers and staff of schools,*
 7 *school boards, universities, or other public educational*
 8 *institutions, including threats directed at—*

9 *(A) the Loudoun County School Board such*
 10 *as “It is too bad that your mother is an ugly*
 11 *communist whore. If she doesn’t quit or resign*
 12 *before the end of the year, we will kill her, but*
 13 *first, we will kill you,” “I am going to gut you*
 14 *like the fat f---ng pig you are when I find you”,*
 15 *or “Your life is being laid bare on the open and*
 16 *dark web. I don’t condone what’s gonna be sent*
 17 *to those close to you or the danger they may be*
 18 *in but you personally do deserve it.”;*

19 *(B) the Pennsbury School District such as*
 20 *“This why Hitler threw you c--ts in a gas cham-*
 21 *ber,” and “You better grow eyes in the back of*
 22 *your head motherf---er,”;*

23 *(C) the North Penn School District such as*
 24 *“Mass of people who know who you are. They*
 25 *will f----ng see your head swinging from a pole.”;*

1 (D) the Dublin City School Board such as
2 “You have become our enemies and you will be
3 removed one way or the other”;

4 (E) the Page County School Board such as
5 “I will bring every single gun loaded and
6 ready”; and

7 (F) the Northwest Allen County School
8 Board such as “bag and tag your ass in a park-
9 ing lot”.

10 (5) Communication or coordination between the
11 Executive Office of the President and the National
12 School Boards Association regarding threats at school
13 board meetings or the Attorney General’s Memo-
14 randum, dated October 4, 2021.

3 *(8) The appointment of Dr. Viola M. Garcia to*
4 *the National Assessment Governing Board.*

5 *(9) Communications sent or received or docu-*
6 *ments in the possession of Mary C. Wall regarding*
7 *threats at school board meetings, the letter, dated Sep-*
8 *tember 29, 2021, from Dr. Viola M. Garcia and Chip*
9 *Slaven to President Joseph Robinette Biden, or the*
10 *Attorney General's Memorandum, dated October 4,*
11 *2021.*
