3 *nication, that refers or relates to the 2023–2028 five-year*
4 *program for offshore oil and gas leasing, including the fol-*
5 *lowing:*

6 (1) *All documents and communications referring*
7 *or relating to the proposed program for offshore oil*
8 *and gas leasing for 2023–2028.*

9 (2) *All documents and communications referring*
10 *or relating to compliance with the Outer Continental*
11 *Shelf Lands Act’s requirement to develop a five-year*
12 *program for offshore oil and gas leasing.*

13 (3) *All documents and communications relating*
14 *to the 2017–2022 five-year program for offshore oil*
15 *and gas leasing, including any reference to—*

16 (A) *the decision to cancel or delay planned*
17 *lease sales;*

18 (B) *the decision to not pursue an appeal to*
19 *the judgment vacating Lease Sale 257; and*

20 (C) *the impact of such program’s expiration*
21 *without the creation of a 2023–2028 five-year*
22 *program for offshore oil and gas leasing.*
