Mr. MCGOVERN, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 256) to repeal the Authorization for Use of Military Force Against Iraq Resolution of 2002; providing for consideration of the bill (H.R. 1187) to provide for disclosure of additional material information about public companies and establish a Sustainable Finance Advisory Committee, and for other purposes; and for other purposes.

- 1 *Resolved*, That upon adoption of this resolution it
- 2 shall be in order to consider in the House the bill (H.R.

1 256) to repeal the Authorization for Use of Military Force
2 Against Iraq Resolution of 2002. All points of order
3 against consideration of the bill are waived. The bill shall
4 be considered as read. All points of order against provi-
5 sions in the bill are waived. The previous question shall
6 be considered as ordered on the bill and on any amend-
7 ment thereto to final passage without intervening motion
8 except: (1) one hour of debate equally divided and con-
9 trolled by the chair and ranking minority member of the
10 Committee on Foreign Affairs or their respective des-
11 ignees; and (2) one motion to recommit.

12 SEC. 2. Upon adoption of this resolution it shall be
13 in order to consider in the House the bill (H.R. 1187)
14 to provide for disclosure of additional material information
15 about public companies and establish a Sustainable Fi-
16 nance Advisory Committee, and for other purposes. All
17 points of order against consideration of the bill are waived.
18 In lieu of the amendment in the nature of a substitute
19 recommended by the Committee on Financial Services now
20 printed in the bill, an amendment in the nature of a sub-
21 stitute consisting of the text of Rules Committee Print
22 117-5 shall be considered as adopted. The bill, as amend-
23 ed, shall be considered as read. All points of order against
24 provisions in the bill, as amended, are waived. The pre-
25 vious question shall be considered as ordered on the bill,

1 as amended, and on any further amendment thereto, to
2 final passage without intervening motion except: (1) one
3 hour of debate equally divided and controlled by the chair
4 and ranking minority member of the Committee on Finan-
5 cial Services or their respective designees; (2) the further
6 amendments described in section 3 of this resolution; (3)
7 the amendments en bloc described in section 4 of this reso-
8 lution; and (4) one motion to recommit.

9 SEC. 3. After debate pursuant to section 2 of this
10 resolution, each further amendment printed in the report
11 of the Committee on Rules not earlier considered as part
12 of amendments en bloc pursuant to section 4 of this reso-
13 lution shall be considered only in the order printed in the
14 report, may be offered only by a Member designated in
15 the report, shall be considered as read, shall be debatable
16 for the time specified in the report equally divided and
17 controlled by the proponent and an opponent, may be
18 withdrawn by the proponent at any time before the ques-
19 tion is put thereon, shall not be subject to amendment,
20 and shall not be subject to a demand for division of the
21 question.

22 SEC. 4. It shall be in order at any time after debate
23 pursuant to section 2 of this resolution for the chair of
24 the Committee on Financial Services or her designee to
25 offer amendments en bloc consisting of further amend-

1 ments printed in the report of the Committee on Rules
2 accompanying this resolution not earlier disposed of.
3 Amendments en bloc offered pursuant to this section shall
4 be considered as read, shall be debatable for 20 minutes
5 equally divided and controlled by the chair and ranking
6 minority member of the Committee on Financial Services
7 or their respective designees, shall not be subject to
8 amendment, and shall not be subject to a demand for divi-
9 sion of the question.

10 SEC. 5. All points of order against the further amend-
11 ments printed in the report of the Committee on Rules
12 or amendments en bloc described in section 4 of this reso-
13 lution are waived.

14 SEC. 6. The provisions of section 202 of the National
15 Emergencies Act (50 U.S.C. 1622) shall not apply to
16 House Joint Resolution 46.

17 SEC. 7. House Resolution 467 is hereby adopted.

18 SEC. 8. (a) At any time through the legislative day
19 of Thursday, June 17, 2021, the Speaker may entertain
20 motions offered by the Majority Leader or a designee that
21 the House suspend the rules as though under clause 1 of
22 rule XV with respect to multiple measures described in
23 subsection (b), and the Chair shall put the question on
24 any such motion without debate or intervening motion.

1 (b) A measure referred to in subsection (a) includes
2 any measure that was the object of a motion to suspend
3 the rules on the legislative day of June 14, 2021, or June
4 15, 2021, in the form as so offered, on which the yeas
5 and nays were ordered and further proceedings postponed
6 pursuant to clause 8 of rule XX.

7 (c) Upon the offering of a motion pursuant to sub-
8 section (a) concerning multiple measures, the ordering of
9 the yeas and nays on postponed motions to suspend the
10 rules with respect to such measures is vacated to the end
11 that all such motions are considered as withdrawn.
