Res. 75) making further continuing appropriations for the fiscal year ending September 30, 2022, and for other purpose; and providing for consideration of the bill (H.R. 6968) to prohibit the importation of energy products of the Russian Federation, and for other purposes.

Mr. MCGOVERN, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of Senate amendment to the bill (H.R. 2471) to measure the progress of post-disaster recovery and efforts to address corruption, governance, rule of law, and media freedoms in Haiti; providing for consideration of the joint resolution (H.J. Res. 75) making further continuing appropriations for the fiscal year ending September 30, 2022, and for other purpose; and providing for consideration of the bill (H.R. 6968)

to prohibit the importation of energy products of the Russian Federation, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to take from the Speaker's table the bill
3 (H.R. 2471) to measure the progress of post-disaster re-
4 covery and efforts to address corruption, governance, rule
5 of law, and media freedoms in Haiti, with the Senate
6 amendment thereto, and to consider in the House, without
7 intervention of any point of order, a motion offered by the
8 chair of the Committee on Appropriations or her designee
9 that the House concur in the Senate amendment with an
10 amendment consisting of the text of Rules Committee
11 Print 117-35. The Senate amendment and the motion
12 shall be considered as read. The motion shall be debatable
13 for one hour equally divided and controlled by the chair
14 and ranking minority member of the Committee on Appro-
15 priations or their respective designees. The previous ques-
16 tion shall be considered as ordered on the motion to its
17 adoption without intervening motion. The question of
18 adoption of the motion shall be divided for a separate vote
19 on all of the matter proposed to be inserted by the amend-
20 ment of the House other than divisions B, C, F, X, and
21 Z, and titles 2 and 3 of division N. The two portions of
22 the divided question shall be considered in the order speci-
23 fied by the Chair. If either portion of the divided question

1 fails of adoption, then the House shall be considered to
2 have made no disposition of the Senate amendment.

3 SEC. 2. The chair of the Committee on Appropria-
4 tions and the chair of the Permanent Select Committee
5 on Intelligence may insert in the Congressional Record not
6 later than March 11, 2022, such material as they may
7 deem explanatory of the Senate amendment and the mo-
8 tion specified in the first section of this resolution.

9 SEC. 3. Upon adoption of this resolution it shall be
10 in order to consider in the House the joint resolution (H.J.
11 Res. 75) making further continuing appropriations for the
12 fiscal year ending September 30, 2022, and for other pur-
13 poses. All points of order against consideration of the joint
14 resolution are waived. The joint resolution shall be consid-
15 ered as read. All points of order against provisions in the
16 joint resolution are waived. The previous question shall be
17 considered as ordered on the joint resolution and on any
18 amendment thereto to final passage without intervening
19 motion except: (1) one hour of debate equally divided and
20 controlled by the chair and ranking minority member of
21 the Committee on Appropriations or their respective des-
22 ignees; and (2) one motion to recommit.

23 SEC. 4. Upon adoption of this resolution it shall be
24 in order to consider in the House the bill (H.R. 6968)
25 to prohibit the importation of energy products of the Rus-

1 sian Federation, and for other purposes. All points of
2 order against consideration of the bill are waived. The bill
3 shall be considered as read. All points of order against
4 provisions in the bill are waived. The previous question
5 shall be considered as ordered on the bill and on any
6 amendment thereto to final passage without intervening
7 motion except: (1) one hour of debate equally divided and
8 controlled by the chair and ranking minority member of
9 the Committee on Ways and Means or their respective des-
10 ignees; and (2) one motion to recommit.
