A BILL

To reauthorize, and increase the total funding cap for, the America’s Agricultural Heritage Partnership, to redesignate the America’s Agricultural Heritage Partnership as the “Silos & Smokestacks National Heritage Area”, and for other purposes.

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting the Silos
5 & Smokestacks National Heritage Area Act”.

1 **SEC. 2. REAUTHORIZATION OF AMERICA’S AGRICULTURAL**
 2 **HERITAGE PARTNERSHIP.**

3 (a) REAUTHORIZATION.—Section 707 of division II
 4 of the Omnibus Parks and Public Lands Management Act
 5 of 1996 (54 U.S.C. 320101 note; Public Law 104–333;
 6 110 Stat. 4267; 127 Stat. 420; 128 Stat. 3801) is amend-
 7 ed by striking “2021” and inserting “2031”.

8 (b) INCREASED TOTAL FUNDING CAP.—Section
 9 708(a) of division II of the Omnibus Parks and Public
 10 Lands Management Act of 1996 (54 U.S.C. 320101 note;
 11 Public Law 104–333; 110 Stat. 4267; 122 Stat. 824; 134
 12 Stat. 1505) is amended, in the second sentence, by strik-
 13 ing “\$17,000,000” and inserting “\$23,000,000”.

14 **SEC. 3. REDESIGNATION OF HERITAGE AREA.**

15 (a) REDESIGNATION.—The America’s Agricultural
 16 Heritage Partnership established by section 703 of divi-
 17 sion II of the Omnibus Parks and Public Lands Manage-
 18 ment Act of 1996 (Public Law 104–333; 110 Stat. 4266)
 19 shall be known and designated as the “Silos & Smoke-
 20 stacks National Heritage Area”.

21 (b) REFERENCES.—Any reference in a law, map, reg-
 22 ulation, document, paper, or other record of the United
 23 States to the heritage area referred to in subsection (a)
 24 shall be deemed to be a reference to the “Silos & Smoke-
 25 stacks National Heritage Area”.
