A BILL

To modify the boundary of the Sunset Crater Volcano Na-
tional Monument in the State of Arizona, and for other
purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Sunset Crater Volcano
5 National Monument Boundary Adjustment Act”.

1 **SEC. 2. DEFINITIONS.**

2 In this Act:

3 (1) **FEDERAL LAND.**—The term “Federal land”
4 means the approximately 97.71 acres of Forest
5 Service land identified as “Proposed transfer from
6 USDA Forest Service to National Park Service” on
7 the Map.

8 (2) **MAP.**—The term “Map” means the map en-
9 titled “Sunset Crater Volcano National Monument
10 Draft Proposed Boundary Adjustment”, numbered
11 039/80,053d, and dated January 2021.

12 (3) **MONUMENT.**—The term “Monument”
13 means the Sunset Crater Volcano National Monu-
14 ment established by Presidential Proclamation 1911
15 (54 U.S.C. 320301 note; 46 Stat. 3023) and redes-
16 ignated by section 15 of the Smith River National
17 Recreation Area Act (Public Law 101–612; 104
18 Stat. 3222).

19 (4) **SECRETARY.**—The term “Secretary” means
20 the Secretary of the Interior, acting through the Di-
21 rector of the National Park Service.

22 **SEC. 3. SUNSET CRATER VOLCANO NATIONAL MONUMENT**
23 **BOUNDARY MODIFICATION.**

24 (a) **TRANSFER OF ADMINISTRATIVE JURISDICTION**
25 **TO NATIONAL PARK SERVICE.**—Administrative jurisdic-

1 tion over the Federal land is transferred from the Forest
2 Service to the National Park Service.

3 (b) MAP AVAILABILITY.—The Map shall be on file
4 and available for inspection in the appropriate offices of
5 the National Park Service.

6 (c) BOUNDARY MODIFICATION.—The boundary of
7 the Monument is modified to include the Federal land.

8 (d) ADMINISTRATION.—Subject to valid existing
9 rights, the Secretary shall administer the Federal land
10 added to the Monument under subsection (a)—

11 (1) as part of the Monument; and

12 (2) in accordance with applicable laws (includ-
13 ing regulations).
