A BILL

To direct the Secretary of the Interior to convey to the city of Eunice, Louisiana, certain Federal land in the State of Louisiana, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Save the Liberty The-
5 atre Act of 2021”.

1 **SEC. 2. DEFINITIONS.**

2 In this Act:

3 (1) CITY.—The term “City” means the city of
4 Eunice, Louisiana.

5 (2) MAP.—The term “map” means the map en-
6 titled “Jean Lafitte National Historical Park and
7 Preserve, Proposed Boundary Revision and Dis-
8 posal”, numbered 467/168813, and dated December
9 2020.

10 (3) SECRETARY.—The term “Secretary” means
11 the Secretary of the Interior.

12 **SEC. 3. LAND CONVEYANCE.**

13 (a) CONVEYANCE AUTHORITY.—The Secretary shall
14 convey to the City, by quitclaim deed and without consid-
15 eration, all right, title, and interest of the United States
16 in and to the parcels of land described in subsection (b).

17 (b) DESCRIPTION OF LAND.—The parcels of land re-
18 ferred to in subsection (a) are lots 5 and 6, less the north
19 27 feet of lot 5, Block 22, of the Original Townsite of
20 Eunice, Louisiana, generally depicted as “Proposed Dis-
21 posal Area” on the map.

22 (c) AVAILABILITY OF MAP.—The map shall be on file
23 and available for public inspection in the appropriate of-
24 fices of the National Park Service.

1 **SEC. 4. BOUNDARY ADJUSTMENTS.**

2 On the conveyance to the City of the land described
3 in section 3(b), the boundary of the Jean Lafitte National
4 Historical Park and Preserve shall be adjusted to ex-
5 clude—

6 (1) the conveyed land; and

7 (2) lots 7 and 8 of the Original Townsite of Eu-
8 nice, Louisiana, generally depicted as “Non-NPS in
9 Current Boundary” on the map.
