A BILL

To amend the Rosie the Riveter/World War II Home Front National Historical Park Establishment Act of 2000 to provide for additional areas to be added to the park, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. ROSIE THE RIVETER/WORLD WAR II HOME**
 2 **FRONT NATIONAL HISTORICAL PARK ADDI-**
 3 **TIONS.**

4 (a) **SHORT TITLE.**—This Act may be cited as the
 5 “Rosie the Riveter National Historic Site Expansion Act”.

6 (b) **ADDITIONS.**—The Rosie the Riveter/World War
 7 II Home Front National Historical Park Establishment
 8 Act of 2000 (16 U.S.C. 410ggg et seq.) is amended as
 9 follows:

10 (1) In section 2(b), by adding at the end the
 11 following: “Not later than 180 days after areas are
 12 added to the park administratively or by Federal
 13 law, the Secretary shall update the map to include
 14 the added areas.”.

15 (2) By adding at the end of section 2, the fol-
 16 lowing:

17 “(c) **ADDITIONAL AREAS INCLUDED.**—In addition to
 18 areas included under subsection (b), the park shall include
 19 the following:

20 “(1) The Nystrom Elementary School—The
 21 Maritime Building, as listed on the National Reg-
 22 ister of Historic Places:

23 “(2) Such other areas as the Secretary deems
 24 appropriate.”.

25 (3) By amending section 3(c)(2) to read as fol-
 26 lows:

1 “(2) OTHER PROPERTY.—Within the bound-
 2 aries of the park, the Secretary may acquire lands,
 3 improvements, waters, or interests therein, by dona-
 4 tion, purchase, exchange or transfer. Any lands, or
 5 interests therein, owned by the State of California or
 6 any political subdivision thereof, may be acquired
 7 only by donation. When any tract of land is only
 8 partly within such boundaries, the Secretary may ac-
 9 quire all or any portion of the land outside of such
 10 boundaries in order to minimize the payment of sev-
 11 erance costs. Land so acquired outside of the bound-
 12 aries may be exchanged by the Secretary for non-
 13 Federal lands within the boundaries. Any portion of
 14 land acquired outside the boundaries and not used
 15 for exchange shall be reported to the General Serv-
 16 ices Administration for disposal for not less than
 17 fair market value under chapter 1 of title 40, United
 18 States Code.”.

19 **SECTION 1. SHORT TITLE.**

20 *This Act may be cited as the “Rosie the Riveter Na-*
 21 *tional Historical Park Expansion Act”.*

22 **SEC. 2. NYSTROM ELEMENTARY SCHOOL ADDITION.**

23 *Section 2 of the Rosie the Riveter/World War II Home*
 24 *Front National Historical Park Establishment Act of 2000*

1 *(16 U.S.C. 410ggg) is amended by striking subsection (b)*
 2 *and inserting the following:*

3 “(b) *AREAS INCLUDED.*—

4 “(1) *IN GENERAL.*—*The boundaries of the park*
 5 *shall include—*

6 “(A)(i) *the areas generally depicted on the*
 7 *map entitled ‘Proposed Boundary Map, Rosie*
 8 *the Riveter/World War II Home Front National*
 9 *Historical Park’, numbered 963/80,000, and*
 10 *dated May 2000; and*

11 “(ii) *the areas depicted as the ‘Proposed*
 12 *Boundary Addition’ on the map entitled ‘Rosie*
 13 *the Riveter/World War II Home Front National*
 14 *Historical Park Proposed Boundary Addition’,*
 15 *numbered 499/168,353, and dated May 2020;*
 16 *and*

17 “(B) *any other historic properties identified*
 18 *by the Secretary as appropriate for addition to*
 19 *the park, subject to the requirement that a his-*
 20 *toric property proposed for addition to the park*
 21 *shall—*

22 “(i) *be determined to be eligible for*
 23 *listing in the National Register of Historic*
 24 *Places;*

1 “(ii) have a direct connection to World
 2 War II home front themes in Richmond,
 3 California; and

4 “(iii) relate to the purpose, signifi-
 5 cance, and interpretive themes of the park.

6 “(2) AVAILABILITY OF MAPS.—The maps referred
 7 to in paragraph (1) shall be on file and available for
 8 public inspection in the appropriate offices of the Na-
 9 tional Park Service.”.

10 **SEC. 3. ADMINISTRATION.**

11 Section 3(a) of the Rosie the Riveter/World War II
 12 Home Front National Historical Park Establishment Act
 13 of 2000 (16 U.S.C. 410ggg–1(a)) is amended by adding at
 14 the end the following:

15 “(3) NYSTROM ELEMENTARY SCHOOL.—Nothing
 16 in this Act affects the authority of the West Contra
 17 Costa Unified School District to administer Nystrom
 18 Elementary School.”.

19 **SEC. 4. COOPERATIVE AGREEMENTS.**

20 Section 3(b) of the Rosie the Riveter/World War II
 21 Home Front National Historical Park Establishment Act
 22 of 2000 (16 U.S.C. 410ggg–1(b)) is amended by adding at
 23 the end the following:

24 “(3) WEST CONTRA COSTA UNIFIED SCHOOL DIS-
 25 TRICT.—

1 “(A) *IN GENERAL.*—*The Secretary may*
2 *enter into cooperative agreements with the West*
3 *Contra Costa Unified School District and other*
4 *appropriate public and private agencies, organi-*
5 *zations, and institutions to carry out the pur-*
6 *poses of this Act.*

7 “(B) *VISITOR INTERPRETATION.*—*The Sec-*
8 *retary shall coordinate visitor interpretation of*
9 *the Nystrom Elementary School site with the*
10 *West Contra Costa Unified School District.”.*
