A BILL

To amend the Reclamation Projects Authorization and Adjustment Act of 1992 to authorize additional projects related to the Salton Sea, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Salton Sea Projects
3 Improvements Act”.

4 **SEC. 2. RESEARCH PROJECT.**

5 Section 1101 of the Reclamation Projects Authoriza-
6 tion and Adjustment Act of 1992 (Public Law 102–575;
7 106 Stat. 4661) is amended—

8 (1) by redesignating subsections (b) through (d)
9 as subsections (c) through (e), respectively;

10 (2) by inserting after subsection (a) the fol-
11 lowing:

12 “(b) **ADDITIONAL PROJECT AUTHORITIES.**—

13 “(1) **IN GENERAL.**—The Secretary of the Inte-
14 rior, acting through the Commissioner of Reclama-
15 tion, may provide grants and enter into contracts
16 and cooperative agreements to carry out projects lo-
17 cated in the area of the Salton Sea in southern Cali-
18 fornia to improve air quality, fish and wildlife habi-
19 tat, recreational opportunities, and water quality, in
20 partnership with—

21 “(A) State, Tribal, and local governments;

22 “(B) water districts;

23 “(C) joint powers authorities, including the
24 Salton Sea Authority;

25 “(D) nonprofit organizations; and

26 “(E) institutions of higher education.

1 “(2) INCLUDED ACTIVITIES.—The projects de-
 2 scribed in paragraph (1) may include—

3 “(A) construction, operation, maintenance,
 4 permitting, and design activities required for
 5 the projects; and

6 “(B) dust suppression projects.”; and

7 ~~(3) in subsection (e) (as so redesignated), by~~
 8 ~~striking “\$10,000,000” and inserting~~
 9 ~~“\$250,000,000”.~~

10 *(3) in subsection (c) (as so redesignated), by*
 11 *striking “project referred to in subsection (a)” and in-*
 12 *serting “projects referred to in subsections (a) and*
 13 *(b)”;* and

14 *(4) in subsection (e) (as so redesignated), by*
 15 *striking “\$10,000,000” and inserting “\$250,000,000”.*

16 **SEC. 3. EXTENSION OF CERTAIN DEADLINES RELATING TO**
 17 **PILOT PROJECTS TO INCREASE COLORADO**
 18 **RIVER SYSTEM WATER TO ADDRESS EFFECTS**
 19 **OF HISTORIC DROUGHT CONDITIONS.**

 21 *Related Agencies Appropriations Act, 2015 (43 U.S.C. 620*
 22 *note; Public Law 113–235), is amended—*

23 *(1) in subsection (b)(2)—*

24 *(A) by striking “additional”; and*

1 *(B) by striking “this Act” and inserting*
2 *“the Salton Sea Projects Improvements Act”;*
3 *(2) in subsection (c)(2), by striking “2022” and*
4 *inserting “2026”; and*
5 *(3) in subsection (d), by striking “2018” and in-*
6 *serting “2027”.*
