the Committee on Commerce, Science, and Transportation

## A BILL

To prohibit the Federal Government from mandating  
vaccination against COVID–19 for interstate travel.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Let Me Travel America  
5       Act”.

6       **SEC. 2. LIMITATION ON AUTHORITY OF SURGEON GEN-**  
7       **ERAL.**

8       Section 361 of the Public Health Service Act (42  
9       U.S.C. 264) is amended by adding at the end the fol-  
10      lowing:

1       “(f) Nothing in this section shall be construed to pro-  
 2 vide the Surgeon General, the Secretary of Health and  
 3 Human Services, or any Federal agency with the authority  
 4 to mandate vaccination against Coronavirus Disease 2019  
 5 (COVID–19) as a prerequisite for interstate travel, trans-  
 6 portation, or movement.”.

7 **SEC. 3. INTERSTATE COMMON CARRIERS.**

8       (a) IN GENERAL.—Chapter 805 of title 49, United  
 9 States Code, is amended by adding at the end the fol-  
 10 lowing:

11 **“§ 80505. COVID–19 vaccination status**

12       “(a) IN GENERAL.—An entity described in subsection  
 13 (b) may not deny service to any individual solely based  
 14 on the vaccination status of the individual with respect  
 15 to the Coronavirus Disease 2019 (COVID–19).

16       “(b) ENTITY DESCRIBED.—An entity referred to in  
 17 subsection (a) is a common carrier or any other entity,  
 18 including a rail carrier (as defined in section 10102, in-  
 19 cluding Amtrak), a motor carrier (as defined in section  
 20 13102), a water carrier (as defined in that section), and  
 21 an air carrier (as defined in section 40102), that—

22               “(1) provides interstate transportation of pas-  
 23 sengers; and

1           “(2) is subject to the jurisdiction of the Depart-  
 2           ment of Transportation or the Surface Transpor-  
 3           tation Board under this title.

4           “(c) SAVINGS PROVISION.—Nothing in this section  
 5           applies to the regulation of intrastate travel, transpor-  
 6           tation, or movement, including the intrastate transpor-  
 7           tation of passengers.”.

8           (b) CLERICAL AMENDMENT.—The analysis for chap-  
 9           ter 805 of title 49, United States Code, is amended by  
 10          inserting after the item relating to section 80504 the fol-  
 11          lowing:

“80505. COVID–19 vaccination status.”.

12   **SEC. 4. RULE OF CONSTRUCTION.**

13          Nothing in this Act, or an amendment made by this  
 14          Act, shall be construed to permit or otherwise authorize  
 15          Congress or an executive agency to enact or otherwise im-  
 16          pose a COVID–19 vaccine mandate.
