A BILL

To improve requirements relating to establishment of a consortium of universities to advise the Secretary of Defense on cybersecurity matters, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “University Cybersecu-
5 rity Consortia Improvement Act of 2021”.

1 **SEC. 2. IMPROVEMENTS TO CONSORTIUM OF UNIVER-**
 2 **SITIES TO ADVISE SECRETARY OF DEFENSE**
 3 **ON CYBERSECURITY MATTERS.**

4 (a) IN GENERAL.—Section 1659 of the National De-
 5 fense Authorization Act for Fiscal Year 2020 (Public Law
 6 116–92; 10 U.S.C. 391 note) is amended—

7 (1) in subsection (a), in the matter before para-
 8 graph (1), by striking “one or more consortia” and
 9 inserting “a consortium”; and

10 (2) in subsection (c), by amending paragraph
 11 (1) to read as follows:

12 “(1) DESIGNATION OF ADMINISTRATIVE
 13 CHAIR.—The Secretary of Defense shall designate
 14 the National Defense University College of Informa-
 15 tion and Cyberspace to function as the administra-
 16 tive chair of the consortium established under sub-
 17 section (a).”.

18 (b) CONFORMING AMENDMENTS.—Such section is
 19 further amended—

20 (1) in subsection (a)(1), by striking “or con-
 21 sortia”;

22 (2) in subsection (b), by striking “or con-
 23 sortia”;

24 (3) in subsection (c)—

25 (A) by striking paragraph (2);

1 (B) by redesignating paragraphs (3) and
 2 (4) as paragraphs (2) and (3), respectively;

3 (C) in paragraph (2), as redesignated by
 4 subparagraph (B)—

5 (i) in the matter before subparagraph
 6 (A)—

7 (I) by striking “Each administra-
 8 tive” and inserting “The administra-
 9 tive”; and

10 (II) by striking “a consortium”
 11 and inserting “the consortium”; and

12 (ii) in subparagraph (A), by striking
 13 “for the term specified by the Secretary
 14 under paragraph (1)”;

15 (D) by amending paragraph (3), as redes-
 16 ignated by subparagraph (B), to read as fol-
 17 lows:

18 “(3) EXECUTIVE COMMITTEE.—The Secretary,
 19 in consultation with the administrative chair, may
 20 form an executive committee for the consortium that
 21 is comprised of representatives of the Federal Gov-
 22 ernment to assist the chair with the management
 23 and functions of the consortium.”; and

24 (4) by amending subsection (d) to read as fol-
 25 lows:

1 “(d) CONSULTATION.—The Secretary shall meet with
2 such members of the consortium as the Secretary con-
3 siders appropriate, not less frequently than twice each
4 year or at such periodicity as is agreed to by the Secretary
5 and the consortium.”.
