following bill; which was read twice and referred to the Committee on
Homeland Security and Governmental Affairs

A BILL

To reauthorize the U.S. Customs and Border Protection
Donations Acceptance Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “CBP Donations Ac-
5 ceptance Program Reauthorization Act”.

6 **SEC. 2. CBP DONATIONS ACCEPTANCE PROGRAM REAU-**
7 **THORIZATION.**

8 Section 482 of the Homeland Security Act of 2002
9 (6 U.S.C. 301a) is amended—

10 (1) in subsection (a)—

1 (A) in paragraph (1)—

2 (i) by amending subparagraph (B) to
3 read as follows:

4 “(B) An existing land port of entry owned
5 or leased by the Federal Government.”; and

6 (ii) in subparagraph (C)—

7 (I) in the matter preceding clause

8 (i), by striking “new Federal Govern-
9 ment-owned land port of entry” and
10 inserting “new land port of entry
11 owned or leased by the Federal Gov-
12 ernment”;

13 (II) in clause (i), by striking
14 “\$50,000,000” and inserting
15 “\$75,000,000”; and

16 (III) by amending clause (ii) to
17 read as follows:

18 “(ii) the fair market value of dona-
19 tions with respect to the land port of entry
20 total \$75,000,000 or less during the imme-
21 diately preceding 5-year period;”; and

22 (B) in paragraph (3), in the matter pre-
23 ceding subparagraph (A), by striking “Federal
24 Government-owned land port of entry” and in-

serting “land port of entry owned or leased by
the Federal Government”;

(2) in subsection (b)—

(A) in the matter preceding paragraph (1),
by striking “Administrator of the General Serv-
ices Administration” and inserting “Adminis-
trator of General Services”;

(B) in paragraph (1)(C)—

(i) in clause (i), by striking
“\$50,000,000” and inserting
“\$75,000,000”; and

(ii) by amending clause (ii) to read as
follows:

“(ii) the fair market value of dona-
tions with respect to the land port of entry
total \$75,000,000 or less over the pre-
ceding 5 years.”; and

(C) in paragraph (4)—

(i) in subparagraph (A), by striking
“terminate” and all that follows and in-
serting “terminate on December 31,
2026.”; and

(ii) in subparagraph (B), by striking
“carrying out” and all that follows and in-
serting “a proposal accepted for consider-

1 ation by U.S. Customs and Border Protec-
 2 tion or the General Services Administra-
 3 tion pursuant to this section or carrying
 4 out a prior pilot program before such ter-
 5 mination date.”;

6 (3) in subsection (c)(6)(B)—

7 (A) by striking “that the donation” and in-
 8 serting the following: “that—

9 “(i) the donation”;

10 (B) by striking the period at the end and
 11 inserting “; and”; and

12 (C) by adding at the end the following:

13 “(ii) the donor will be notified in the
 14 Donations Acceptance Agreement that the
 15 donor will be financially responsible for all
 16 costs and operating expenses related to the
 17 operation, maintenance, and repair of the
 18 donated real property until U.S. Customs
 19 and Border Protection provides the donor
 20 written notice that the donor has been re-
 21 lieved of such responsibility.”;

22 (4) in subsection (d), in the matter preceding
 23 paragraph (1), by striking “an annual” and insert-
 24 ing “a biennial”; and

- 1 (5) in subsection (e), by striking “Adminis-
- 2 trator of the General Services Administration” and
- 3 inserting “Administrator of General Services”.
