Mr. MANCHIN introduced the following bill; which was read twice and referred to the Committee on Environment and Public Works

A BILL

To amend title 40, United States Code, to relocate the headquarters of the Appalachian Regional Commission, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “ARC Relocation Act”.

5 **SEC. 2. HEADQUARTERS OF THE APPALACHIAN REGIONAL** 6 **COMMISSION.**

7 (a) FINDINGS.—Congress finds that—

8 (1) Senate Report 115–258, accompanying S.
9 2975 (115th Congress), contained bipartisan lan-
10 guage expressing a belief that “if the Appalachian

1 Regional Commission is going to move, it should
2 move to the State of West Virginia”;

3 (2) the greater Washington, DC, metropolitan
4 area accounts for 22 percent of the Federal work-
5 force, yet only accounts for less than 2 percent of
6 the population of the United States;

7 (3) the headquarters of the Delta Regional Au-
8 thority, the Denali Commission, and the Northern
9 Border Regional Commission are already
10 headquartered in their respective regions;

11 (4) headquartering a regional commission with-
12 in the jurisdiction of the commission can reduce ad-
13 ministrative overhead, increase accountability to the
14 people the commission was designed to serve, and
15 enhance confidence in the work of that commission;

16 (5) the Appalachian Regional Commission is an
17 economic development agency focused on the Appa-
18 lachian region and representing a partnership of
19 Federal, State, and local governments across 13
20 States;

21 (6) despite the reach of the Appalachian Re-
22 gional Commission across 13 States, West Virginia
23 remains the only State fully within the jurisdiction
24 of the Appalachian Regional Commission;

1 (7) West Virginia is located at the midpoint of
2 the Appalachian region;

3 (8) West Virginia is central to the creation of
4 the Appalachian Regional Commission;

5 (9) following the visit of President John F.
6 Kennedy to West Virginia during his presidential
7 campaign in 1960, he was moved by the poverty he
8 observed there and he worked to create the Appa-
9 lachian Regional Commission through an Act of
10 Congress in 1965;

11 (10) the Appalachian Regional Commission is
12 critical to assisting communities impacted by the de-
13 cline of the coal industry as well as the opioid crisis,
14 and no State has seen a greater impact from those
15 issues than West Virginia;

16 (11) one of the top goals of the Appalachian
17 Regional Commission is to spur economic opportuni-
18 ties in the Appalachian region by investing in strate-
19 gies that strengthen the economy of the region; and

20 (12) an effective way to achieve the goal re-
21 ferred to in paragraph (11) is to directly invest in
22 the region by relocating the workforce of the Appa-
23 lachian Regional Commission to the region itself.

1 (b) HEADQUARTERS.—Section 14301 of title 40,
2 United States Code, is amended by adding at the end the
3 following:

4 “(g) HEADQUARTERS.—The headquarters of the
5 Commission shall be located in the State of West Vir-
6 ginia.”.

7 (c) IMPLEMENTATION.—The Federal Cochairman of
8 the Appalachian Regional Commission shall take such ac-
9 tions as may be necessary to carry out the amendment
10 made by subsection (b).
