A BILL

To amend the Water Infrastructure Improvements for the Nation Act to extend certain contract prepayment authority.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Western Water Acceler-*
 5 *ated Revenue Repayment Act”.*

6 **SEC. 2. AMENDMENTS TO THE WIIN ACT.**

7 (a) *OFFSETS AND WATER STORAGE ACCOUNT.*—*Sec-*
 8 *tion 4011(d)(2) of the Water Infrastructure Improvements*
 9 *for the Nation Act (Public Law 114–322) is amended by*
 10 *inserting “that are directed by project-specific statutes in*
 11 *effect prior to the date of passage of this Act to accounts*
 12 *other than the General Reclamation Fund” before the semi-*
 13 *colon.*

14 (b) *EXTENSION OF PREPAYMENT AUTHORITY.*—*Sec-*
 15 *tion 4013 of the Water Infrastructure Improvements for the*
 16 *Nation Act (Public Law 114–322) is amended—*

17 (1) *in paragraph (1), by striking “; and” and*
 18 *inserting a semicolon;*

19 (2) *in paragraph (2), by striking the period and*
 20 *inserting “; and”; and*

21 (3) *by adding at the end the following:*

1 “(3) *section 4011.*”.
