Ms. McCLELLAN introduced the following bill; which was referred to the Committee on Armed Services

A BILL

To direct the Secretary of Defense to report on the Military OneSource program of the Department of Defense.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Military OneSource
5 Transparency Act”.

6 **SEC. 2. REPORTS ON MILITARY ONESOURCE.**

7 (a) FIRST REPORT.—Not later than 180 days after
8 the date of the enactment of this Act, the Secretary of
9 Defense shall submit to the Committees on Armed Serv-
10 ices of the Senate and House of Representatives a report

1 regarding the Military OneSource program of the Depart-
2 ment of Defense. Such report under shall include the fol-
3 lowing elements:

4 (1) A history of the program, including origin,
5 development, and expansion.

6 (2) An accounting of costs to the Federal Gov-
7 ernment to operate the program during fiscal years
8 2019 through 2023.

9 (3) Use of the program during fiscal years
10 2019 through 2023, including—

11 (A) the total number of individuals who
12 used the program, disaggregated by whether
13 such use was through a phone call or the
14 website;

15 (B) the number of members of the Armed
16 Forces who have used the program,
17 disaggregated, to the extent practicable, by
18 Armed Force, race, gender, age, marital status,
19 and duty location; and

20 (C) the most commonly used services of-
21 fered through the program.

22 (4) How records for such usage are kept and
23 protected.

24 (5) A list of all services offered through the
25 program.

1 (6) The cost of any service to a member.

2 (7) Services to be added to the program.

3 (8) Criteria by which services offered through
4 the program are added or discontinued.

5 (b) SUBSEQUENT REPORTS.—Not less than once in
6 each of fiscal years 2025 through 2029, the Secretary
7 shall submit to the Committees on Armed Services of the
8 Senate and House of Representatives a report regarding
9 such Military OneSource program. Each such subsequent
10 report shall include the following elements with regards
11 to the fiscal year preceding the date of such report:

12 (1) An accounting of costs to the Federal Gov-
13 ernment to operate the program.

14 (2) Use of the program, including—

15 (A) the total number of individuals who
16 used the program, disaggregated by whether
17 such use was through a phone call or the
18 website;

19 (B) the number of members of the Armed
20 Forces who have used the program,
21 disaggregated, to the extent practicable, by
22 Armed Force, race, gender, age, marital status,
23 and duty location; and

24 (C) the most commonly used services of-
25 fered through the program.

1 (3) A list of all services offered through the
2 program.

3 (4) The cost of any service to a member.

4 (5) Services added to, or discontinued from, the
5 program.

6 (6) Criteria by which services offered through
7 the program are added or discontinued.
