A BILL

To direct the Comptroller General of the United States to conduct a review of the Homeland Security Information Network, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Streamlining Law En-
5 forcement Information Sharing Act”.

6 **SEC. 2. COMPTROLLER GENERAL REPORT ON THE HOME-**
7 **LAND SECURITY INFORMATION NETWORK.**

8 Not later than one year after the date of the enact-
9 ment of this Act, the Comptroller General of the United
10 States shall submit to the Committee on Homeland Secu-
11 rity and the Permanent Select Committee on Intelligence
12 of the House of Representatives and the Committee on
13 Homeland Security and Governmental Affairs and the Se-
14 lect Committee on Intelligence of the Senate a report that
15 includes the following:

16 (1) An examination of how the Homeland Secu-
17 rity Information Network is used to share informa-
18 tion with Federal, State, local, Tribal, and territorial
19 law enforcement partners.

20 (2) A comparison of the use, by such law en-
21 forcement partners, on both desktops and mobile ap-
22 plications of the Homeland Security Information
23 Network to the use of other tools, including
24 JusticeConnect of the Federal Bureau of Investiga-

1 tion, which facilitate real-time exchanges of intel-
2 ligence among such law enforcement partners.

3 (3) An assessment of the cost, effectiveness,
4 and efficacy of the Homeland Security Information
5 Network.

6 (4) An assessment of the current policies of the
7 Homeland Security Information Network and the ef-
8 ficacy of such policies in protecting the civil rights,
9 civil liberties, and privacy of individuals.

10 (5) An analysis of any other information the
11 Comptroller General determines appropriate.
