which was referred to the Committee on Education and the Workforce

A BILL

To amend the Higher Education Act of 1965 to increase the knowledge and skills of principals and school leaders regarding early childhood education.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Creating Early Child-
5 hood Leaders Act”.

6 **SEC. 2. FINDINGS AND PURPOSE.**

7 (a) FINDINGS.—Congress finds the following:

8 (1) Since principals and school leaders have the
9 second largest in-school impact on student achieve-
10 ment (after teachers), a principal or school leader’s

1 knowledge has a substantial impact on the teachers
 2 and students under the principal or school leader’s
 3 supervision.

4 (2) Principals and school leaders are increas-
 5 ingly being asked to supervise teachers and children
 6 in pre-kindergarten programs, yet school leaders
 7 often do not have training in early childhood edu-
 8 cation.

9 (3) Given the critical development that occurs
 10 in a child’s early life and the impacts of this develop-
 11 mental period on later life outcomes, understanding
 12 the standards of early childhood education is par-
 13 ticularly important.

14 (b) PURPOSE.—The purpose of this Act is to ensure
 15 that principals and school leaders are able to effectively
 16 support teachers in providing pre-kindergarten students
 17 with developmentally appropriate instruction.

18 **SEC. 3. SCHOOL LEADER TRAINING REGARDING EARLY**
 19 **CHILDHOOD EDUCATION.**

20 Section 202(f)(1)(B) of the Higher Education Act of
 21 1965 (20 U.S.C. 1022a(f)(1)(B)) is amended—

22 (1) by striking clause (v) and inserting the fol-
 23 lowing:

24 “(v) engage and involve parents, com-
 25 munity members, the local educational

1 agency, businesses, providers of early child-
2 hood education programs, and other com-
3 munity leaders, to leverage additional re-
4 sources to improve student academic
5 achievement;”;

6 (2) in clause (vi), by striking the period at the
7 end and inserting “; and”; and

8 (3) by adding at the end the following:

9 “(vii) understand child development,
10 social and emotional development, develop-
11 mentally appropriate behavioral interven-
12 tions and supports, and effective instruc-
13 tional leadership skills for children from
14 birth through age 8, in order to effectively
15 manage and support developmentally ap-
16 propriate early childhood education pro-
17 grams.”.
