A BILL

To require the Agricultural Research Service to conduct research relating to wildfire smoke exposure on wine grapes, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Smoke Exposure Re-
5 search Act of 2023”.

6 **SEC. 2. WILDFIRE SMOKE EXPOSURE RESEARCH ON WINE**
7 **GRAPES.**

8 (a) RESEARCH.—

1 (1) IN GENERAL.—The Secretary of Agri-
2 culture, acting through the Administrator of the Ag-
3 ricultural Research Service, shall—

4 (A) conduct research—

5 (i) to identify the compounds respon-
6 sible for smoke taint; and

7 (ii) to establish standard methodolo-
8 gies for sampling and testing smoke-ex-
9 posed wine grapes and smoke-affected
10 wines, including fast and inexpensive
11 screening methods;

12 (B) establish a reliable database of back-
13 ground levels of smoke taint compounds that
14 occur naturally in wine grapes;

15 (C) develop risk assessment tools or miti-
16 gation methods to reduce or eliminate smoke
17 taint; and

18 (D) study compounds that can act as a
19 barrier between wine grapes and smoke com-
20 pounds.

21 (2) COORDINATION.—The Secretary of Agri-
22 culture, acting through the Administrator of the Ag-
23 ricultural Research Service, shall carry out para-
24 graph (1) in coordination with land-grant colleges
25 and universities (as defined in section 1404 of the

1 National Agricultural Research, Extension, and
2 Teaching Policy Act of 1977 (7 U.S.C. 3103)) lo-
3 cated in the States of California, Oregon, and Wash-
4 ington that have conducted research on the effects
5 of smoke exposure on viticulture and enology oper-
6 ations and practices.

7 (b) AUTHORIZATION OF APPROPRIATIONS.—There is
8 authorized to be appropriated to carry out this section
9 \$6,500,000 for each of fiscal years 2024 through 2028,
10 to remain available until expended.
