1 **SECTION 1. REDESIGNATION OF THE COTTONWOOD VIS-**

5 (a) *REDESIGNATION.*—The Cottonwood Visitor Cen-
 6 ter at Joshua Tree National Park shall be known and des-
 7 ignated as the “Senator Dianne Feinstein Visitor Center”.

8 (b) *REFERENCES.*—Any reference in a law, map, reg-
 9 ulation, document, paper, or other record of the United
 10 States to the visitor center referred to in subsection (a)
 11 shall be deemed to be a reference to the “Senator Dianne
 12 Feinstein Visitor Center”.

13 **SECTION 1. REDESIGNATION OF THE COTTONWOOD VIS-**

17 (a) *REDESIGNATION.*—The Cottonwood Visitor Center
 18 at Joshua Tree National Park, or any successor to that vis-
 19 itor center, shall be known and designated as the “Dianne
 20 Feinstein Visitor Center”.

21 (b) *REFERENCES.*—Any reference in a law, map, regu-
 22 lation, document, paper, or other record of the United
 23 States to the visitor center referred to in subsection (a) shall
 24 be deemed to be a reference to the “Dianne Feinstein Visitor
 25 Center”.
