Ms. KLOBUCHAR (for herself and Mr. DURBIN) introduced the following bill; which was read twice and referred to the Committee on Rules and Administration

A BILL

To amend the Federal Election Campaign Act of 1971 to require disclosures to contributors regarding recurring contributions or donations.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Rescuing Every Con-
5 tributor from Unwanted Recurrences (RECUR) Act”.

1 **SEC. 2. REQUIRED DISCLOSURES TO CONTRIBUTORS RE-**
2 **GARDING RECURRING CONTRIBUTIONS OR**
3 **DONATIONS.**

4 (a) IN GENERAL.—Section 318(d) of the Federal
5 Election Campaign Act of 1971 (52 U.S.C. 30120(d)) is
6 amended by adding at the end the following new para-
7 graph:

8 “(3) COMMUNICATIONS THAT SOLICIT RECUR-
9 RING CONTRIBUTIONS OR DONATIONS.—

10 “(A) IN GENERAL.—Any person soliciting
11 a recurring contribution to a political com-
12 mittee, a recurring contribution to fund an
13 independent expenditure, or a recurring dona-
14 tion to fund an electioneering communication
15 must receive the affirmative consent of the con-
16 tributor or donor at the arrangement of the re-
17 curring contribution or donation. Passive action
18 by the contributor or donor, such as failing to
19 uncheck a pre-checked box authorizing a recur-
20 ring contribution, shall not meet the require-
21 ment of affirmative consent under this subpara-
22 graph.

23 “(B) REQUIREMENTS.—Any person ac-
24 cepting a recurring contribution or donation de-
25 scribed in subparagraph (A) shall—

1 “(i) provide a receipt for an initial
2 contribution or donation and each recur-
3 rence that clearly and conspicuously dis-
4 closes all material terms;

5 “(ii) provide all information needed to
6 cancel recurring contributions or donations
7 in each communication with the contrib-
8 utor or donor that concerns the contribu-
9 tion or donation; and

10 “(iii) shall immediately cancel recur-
11 ring contributions or donations upon re-
12 quest of the contributor or donor.”.

13 (b) DEADLINE FOR REGULATIONS.—Not later than
14 180 days after the date of enactment of this Act, the Fed-
15 eral Election Commission shall promulgate regulations to
16 carry out this Act.
