## A BILL

To amend the Workforce Innovation and Opportunity Act to create a pilot program to award grants to units of general local government and community-based organizations to create jobs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Jobs Now Act of  
5 2025”.

1 **SEC. 2. GRANTS TO UNITS OF GENERAL LOCAL GOVERN-**  
2 **MENT.**

3 (a) PILOT PROGRAM.—Subtitle D of title I of the  
4 Workforce Innovation and Opportunity Act (29 U.S.C.  
5 3221 et seq.) is amended by adding at the end the fol-  
6 lowing:

7 **“SEC. 173. PILOT PROGRAM.**

8 “(a) PROGRAM AUTHORIZED.—Notwithstanding sec-  
9 tion 181(e), from the amounts appropriated under sub-  
10 section (h), the Secretary shall carry out a 2-year pilot  
11 program to award grants, on a competitive basis, to units  
12 of general local government or community-based organiza-  
13 tions to retain, employ, or train employees providing a  
14 public service for a unit of general local government.

15 “(b) UNIT OF GENERAL LOCAL GOVERNMENT DE-  
16 FINED.—For purposes of this section, the term ‘unit of  
17 general local government’ means any general purpose po-  
18 litical subdivision of a State, or the United States Virgin  
19 Islands, Guam, American Samoa, the Commonwealth of  
20 the Northern Mariana Islands, the freely associated states  
21 of the Republic of the Marshall Islands, the Federated  
22 States of Micronesia, or the Republic of Palau, that has  
23 the power to levy taxes and spend funds, as well as general  
24 corporate and police powers.

25 “(c) USES OF FUNDS.—

26 “(1) REQUIRED USES.—

1           “(A) IN GENERAL.—Subject to subpara-  
2 graph (B), a unit of general local government  
3 or community-based organization shall use not  
4 less than 50 percent of the grant funds received  
5 under this section to—

6           “(i) in the case of a unit, retain em-  
7 ployees of such unit who are providing a  
8 public service for the unit and who would  
9 otherwise be laid off as a consequence of  
10 budget cuts; and

11           “(ii) in the case of an organization,  
12 retain employees of the organization who  
13 are providing a public service for the unit  
14 in which the organization is located and  
15 who would otherwise be laid off as a con-  
16 sequence of budget cuts.

17           “(B) EXCEPTION.—In a case in which 50  
18 percent of a grant amount received under this  
19 section would exceed the amount needed for a  
20 unit or organization to retain the employees de-  
21 scribed in subparagraph (A), the unit or organi-  
22 zation may use only the amount needed to re-  
23 tain such employees for such purpose.

24           “(2) AUTHORIZED USES.—After using grant  
25 funds received under this section in accordance with

1 paragraph (1), a unit of general local government or  
2 community-based organization may use any remain-  
3 ing grant funds provided under this section to—

4 “(A) in the case of a unit of general local  
5 government—

6 “(i) employ individuals in new posi-  
7 tions providing a public service for the  
8 unit; or

9 “(ii) train individuals for new public  
10 service positions for the unit; and

11 “(B) in the case of a community-based or-  
12 ganization—

13 “(i) employ individuals in new posi-  
14 tions that would provide a public service  
15 for the unit in which the organization is lo-  
16 cated or services in the private sector; or

17 “(ii) train individuals for any such po-  
18 sitions.

19 “(d) PRIORITY FOR CERTAIN INDIVIDUALS.—The  
20 Secretary shall encourage each unit of general local gov-  
21 ernment and each community-based organization receiving  
22 a grant under this section to use such grant funds to re-  
23 tain, employ, or train—

24 “(1) veterans;

25 “(2) individuals with disabilities;

1           “(3) individuals who are receiving unemploy-  
2           ment benefits; or

3           “(4) dislocated workers.

4           “(e) PRIORITY FOR CERTAIN UNITS AND ORGANIZA-  
5           TIONS.—

6           “(1) UNITS.—In awarding grants to units of  
7           general local government under this section, the Sec-  
8           retary shall give priority to units of general local  
9           government with high unemployment, foreclosure,  
10          and poverty rates as compared to other units of gen-  
11          eral local government applying to receive a grant  
12          under this section.

13          “(2) ORGANIZATIONS.—In awarding grants to  
14          units of general local government under this section,  
15          the Secretary shall give priority to community-based  
16          organizations located in units of general local gov-  
17          ernment with high unemployment, foreclosure, and  
18          poverty rates as compared to other units of general  
19          local government applying to receive a grant under  
20          this section.

21          “(f) APPLICATION.—Each unit of general local gov-  
22          ernment or community-based organization desiring to re-  
23          ceive a grant under this section shall submit an application  
24          to the Secretary at such time, in such manner, and con-  
25          taining such information as the Secretary may require.

1       “(g) REPORT.—Not later than 2 years after the first  
2 appropriation of funds under subsection (h), the Secretary  
3 shall submit to Congress, a report on—

4           “(1) the number and percentage of individuals  
5 hired or trained, and the number and percentage of  
6 employees of units retained, as a result of a grant  
7 under this section; and

8           “(2) best practices in carrying out a grant pro-  
9 gram to hire, train, or retain employees of units of  
10 general local government.

11       “(h) AUTHORIZATION OF APPROPRIATIONS.—There  
12 are authorized to be appropriated \$1,000,000,000 to carry  
13 out this section for fiscal years 2026 and 2027.”.

14       (b) CONFORMING AMENDMENT.—The table of con-  
15 tents in section 1(b) of the Workforce Innovation and Op-  
16 portunity Act is amended by inserting after the item relat-  
17 ing to section 172 the following:

“Sec. 173. Pilot program.”.
