A BILL

To amend the Federal Food, Drug, and Cosmetic Act to require a warning label advising that the effects of mifepristone can be counteracted, to amend the Public Health Service Act to establish a hotline to provide information to women seeking to counteract the effects of mifepristone, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Second Chance for
3 Moms Act of 2025”.

4 **SEC. 2. MIFEPRISTONE WARNING LABEL AND HOTLINE.**

5 (a) WARNING LABEL.—

6 (1) IN GENERAL.—Section 502 of the Federal
7 Food, Drug, and Cosmetic Act (21 U.S.C. 352) is
8 amended by adding at the end the following:

9 “(hh) If it is the drug mifepristone, and its labeling
10 does not bear the following statement printed in con-
11 spicuous text: ‘WARNING: Medical evidence suggests that
12 the abortifacient effects of mifepristone can be counter-
13 acted by natural progesterone, which can increase the
14 chance of fetal survival. The American Society for Repro-
15 ductive Medicine has determined that natural progester-
16 one is safe in the first trimester of pregnancy. For more
17 information, call [____].’ (with the blank filled in to
18 refer to the appropriate number for the hotline under sec-
19 tion 1009 of the Public Health Service Act).”.

20 (2) EFFECTIVE DATE.—Section 502(hh) of the
21 Federal Food, Drug, and Cosmetic Act (as added by
22 paragraph (1)) applies beginning on the date that is
23 6 months after the date of enactment of this Act.

24 (b) HOTLINE.—Title X of the Public Health Service
25 Act (42 U.S.C. 300 et seq.) is amended by adding at the
26 end the following:

1 **“SEC. 1009. HOTLINE FOR REVERSAL OF EFFECTS OF**
2 **MIFEPRISTONE.**

3 “(a) IN GENERAL.—The Secretary shall establish or
4 maintain, directly or by grant or contract, a toll-free hot-
5 line to provide support for 24 hours a day, 7 days a week,
6 for women seeking to reverse the effects of the drug
7 mifepristone.

8 “(b) REFERRALS TO APR PROVIDERS ONLY.—A re-
9 ferral through the hotline described in subsection (a) may
10 only be made to a health care provider that provides abor-
11 tion pill reversal services.”.
