**A BILL**

To provide for joint reports by relevant Federal agencies  
to Congress regarding incidents of terrorism, and for  
other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLES.**

4 This Act may be cited as the “Reporting Efficiently  
5 to Proper Officials in Response to Terrorism Act of 2025”  
6 or the “REPORT Act”.

1 **SEC. 2. DUTY TO REPORT.**

2 (a) DEFINITIONS.—In this section:

3 (1) ACT OF TERRORISM.—The term “act of ter-  
4 rorism” has the meaning given such term in section  
5 3077(1) of title 18, United States Code.

6 (2) APPROPRIATE CONGRESSIONAL COMMIT-  
7 TEES.—The term “appropriate congressional com-  
8 mittees” means—

9 (A) the Committee on Homeland Security  
10 and Governmental Affairs of the Senate;

11 (B) the Committee on the Judiciary of the  
12 Senate;

13 (C) the Select Committee on Intelligence of  
14 the Senate;

15 (D) the Committee on Homeland Security  
16 of the House of Representatives;

17 (E) the Committee on the Judiciary of the  
18 House of Representatives; and

19 (F) the Permanent Select Committee on  
20 Intelligence of the House of Representatives.

21 (b) REQUIREMENT.—

22 (1) IN GENERAL.—Whenever an act of ter-  
23 rorism occurs in the United States, the Secretary of  
24 Homeland Security, the Attorney General, the Direc-  
25 tor of the Federal Bureau of Investigation, and, as

1 appropriate, the head of the National Counterter-  
2 rorism Center shall—

3 (A) submit to the appropriate congres-  
4 sional committees, by not later than 1 year  
5 after the completion of the investigation con-  
6 cerning such act by the primary Government  
7 agency conducting such investigation, an un-  
8 classified report (which may be accompanied by  
9 a classified annex) concerning such act of ter-  
10 rorism; and

11 (B) make the report required under sub-  
12 paragraph (A) available on a publicly accessible  
13 website.

14 (2) OTHER REPORTS.—Reports required under  
15 this subsection may be combined into a quarterly re-  
16 port submitted to Congress.

17 (3) AVAILABILITY.—Each unclassified report  
18 and classified annex described in paragraph (1)(A)  
19 shall be made available upon request by any Member  
20 of Congress.

21 (c) CONTENT OF REPORTS.—Each report submitted  
22 pursuant to subsection (b) shall—

23 (1) include a statement of the facts of each act  
24 of terrorism covered by the report, to the extent

1 such facts are known at the time the report is sub-  
2 mitted to the appropriate congressional committees;

3 (2) identify any gaps in homeland or national  
4 security that could be addressed to prevent similar  
5 future acts of terrorism; and

6 (3) include any recommendations for additional  
7 measures that could be taken to improve homeland  
8 or national security, including recommendations re-  
9 lating to potential changes in law enforcement prac-  
10 tices or changes in law, with particular attention to  
11 changes that could help prevent future acts of ter-  
12 rorism.

13 (d) EXCEPTION.—

14 (1) IN GENERAL.—If the Secretary of Home-  
15 land Security, the Attorney General, or the Director  
16 of the Federal Bureau of Investigation determines  
17 any information described in subsection (c) that is  
18 required to be included in the report required under  
19 subsection (b) could jeopardize an ongoing investiga-  
20 tion or prosecution, the Secretary, Attorney General,  
21 or Director, as the case may be—

22 (A) may withhold from reporting such in-  
23 formation; and

24 (B) shall notify the appropriate congres-  
25 sional committees of such determination.

1           (2) SAVINGS PROVISION.—Withholding of infor-  
2           mation pursuant to a determination described in  
3           paragraph (1) shall not affect, in any manner, the  
4           responsibility of the appropriate Federal official to  
5           submit a report required under subsection (b) con-  
6           taining other information described in subsection (c)  
7           that is not subject to such determination.

8           (e) SUNSET.—This section shall terminate on the  
9           date that is 5 years after the date of the enactment of  
10          this Act.

11          (f) SAVINGS PROVISION.—Nothing in this Act may  
12          be construed to provide the National Counterterrorism  
13          Center with prosecutorial or investigatory authority.
