

PUBLIC BILLS AND RESOLUTIONS

CONSTITUTIONAL AUTHORITY STATEMENT.

Pursuant to claue 7 of rule XII of the Rules of the House of Representatives,

the following statements are submitted regarding the specific powers granted to Congress in the Constitution to enact the accompanying bill or joint resolution.

By Mr. NADLER:

H.R. 5374.

Congress has the power to enact this legislation pursuant to the following:

Article 1; Section 8, Clause 3 of the U.S. Constitution, which gives Congress the power "[t]o regulate commerce with foreign nations, and among the several states, and with the Indian tribes."
