COLORADO WILDERNESS ACT OF 2021

Mr. NEGUSE. Madam Speaker, pursuant to House Resolution 147, I call up the bill (H.R. 803) to designate certain lands in the State of Colorado as components of the National Wilderness Preservation System, and for other purposes, and ask for its immediate consideration in the House.

The Clerk read the title of the bill.

The SPEAKER pro tempore. Pursuant to House Resolution 147, an amendment in the nature of a substitute consisting of the text of Rules Committee Print 117-2, modified by the amendment printed in part A of House Report 117-6, is adopted and the bill, as amended, is considered read.

The text of the bill, as amended, is as follows:

H. R. 803

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE; TABLE OF CONTENTS.

(a) *SHORT TITLE.*—This Act may be cited as the “Protecting America’s Wilderness and Public Lands Act”.
