H.R. 7545.

Congress has the power to enact this legislation pursuant to the following:

Clause 3 of Section 8 of Article I of the Constitution (the Commerce Clause)

By Ms. JACKSON LEE:

H.R. 7546.

Congress has the power to enact this legislation pursuant to the following:

Article I, Section 8, clauses 18 of the Constitution of the United States which states that Congress has the power "to make all laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States, or in any Department or Officer thereof."

By Mr. BLUMENAUER:

H.R. 7547.

Congress has the power to enact this legislation pursuant to the following:

Clause 1 of Section 8 of Article I of the Constitution.

By Mrs. BOEBERT:

H.R. 7548.

Congress has the power to enact this legislation pursuant to the following:

Article 1 Section 8: The Congress shall have Power To lay and collect Taxes, Duties, Imposts and Excises, to pay the Debts and provide for the common Defense and general Welfare of the United States; but all Duties, Imposts and Excises shall be uniform throughout the United States;
