#### DEMOCRATS ARE WORKING TO LOWER COSTS FOR WORKING FAMILIES

(Ms. GARCIA of Texas asked and was given permission to address the House for 1 minute and to revise and extend her remarks.)

Ms. GARCIA of Texas. Mr. Speaker, I rise to celebrate House Democrats' efforts to lower costs for working families across America.

#### THE ENERGY CRISIS
