S 71

At the request of Mr. BUDD, the name of the Senator from Arkansas (Mr. COTTON) was added as a cosponsor of S. 711, a bill to require the Secretary of the Treasury to mint coins in commemoration of the invaluable service that working dogs provide to society.

S. 815

At the request of Mr. Tester, the names of the Senator from Wisconsin (Ms. Baldwin) and the Senator from Rhode Island (Mr. Whitehouse) were added as cosponsors of S. 815, a bill to award a Congressional Gold Medal to the female telephone operators of the Army Signal Corps, known as the "Hello Girls".

S. 863

At the request of Mr. King, the name of the Senator from Nebraska (Mrs. Fischer) was added as a cosponsor of S. 863, a bill to establish a temporary commission to develop a consensus and actionable recommendations on a comprehensive grand strategy with respect to the United States relationship with the People's Republic of China for purposes of ensuring a holistic approach toward the People's Republic of China across all Federal departments and agencies.

S. 1174

At the request of Mr. Whitehouse, the name of the Senator from Minnesota (Ms. Klobuchar) was added as a cosponsor of S. 1174, a bill to amend the Internal Revenue Code of 1986 to increase funding for Social Security and Medicare.

S. 1201

At the request of Mr. Scott of South Carolina, the name of the Senator from North Carolina (Mr. Tillis) was added as a cosponsor of S. 1201, a bill to reform the labor laws of the United States, and for other purposes.
