

H.R. 9304. A bill to require the Director of the National Cancer Institute to conduct a review of the current state of stomach cancer incidence, prevention, screening, awareness, and future public health importance, and for other purposes; to the Committee on Energy and Commerce.

H.R. 9305. A bill to direct the Secretary of Health and Human Services to make grants to local governments for the training of local law enforcement officers on public health threats arising from violations of building codes, and for other purposes; to the Committee on Transportation and Infrastructure.

H.R. 9306. A bill to amend the Infrastructure Investment and Jobs Act to modify the Safe Streets and Roads for All program; to the Committee on Transportation and Infrastructure.

A bill to direct the Comptroller General of the United States to report to Congress on the compliance under the Architectural Barriers Act of 1968 of all office buildings under the jurisdiction, custody, or control of the General Services Administration, and for other purposes; to the Committee on Transportation and Infrastructure
