In 2023, the North Mississippi Fish Hatchery was also renamed the "Bob Tyler Fish Hatchery," in his honor.

Coach Tyler's accomplishments and impact extended far beyond the football field. Following his retirement from coaching, he would go on to serve as deputy director of the Mississippi Department of Wildlife, Fisheries and Parks, help start the Archery in Mississippi Schools program, and support the Fallen Officers Memorial. He also served as the director of economic development for Yalobusha County for 15 years until 2022.

Coach Tyler, an active member of the First Baptist Church of Water Valley, MS, was a dedicated family man, married to his high school sweetheart and wife of 69 years, Dale. They raised three children—Breck, Cam, and Drew—and wholeheartedly welcomed eight-grandchildren and eight great grandchildren.

For myself and all those who knew Coach Tyler, I honor his years of service and a life well lived. He will be remembered as a great Mississippian, who dedicated his life to the game that he loved and to the generations of players and people that he educated on the field and in life.

I pray his family and friends find solace in that legacy. My condolences go out to all of them.●

TRIBUTE TO TREY AND CASEY FILTER AND PAUL CONTRERAS

● Mr. SCHMITT. Madam President, today I rise in recognition of three great people: Trey Filter of Wichita, KS, Casey Filter of Wichita, KS, and Paul Contreras of Bellevue, NE. On February 14 of this year, the Kansas City Chiefs secured a Super Bowl victory for the second year in a row. And just like the parade from a year ago, Chiefs fans of all stripes descended onto Kansas City's Union Station to celebrate this great achievement. As this parade came and went and celebration boiled down, gunfire tragically rang out. Reports say these shots were followed by cries of "Get him, get him," and "Stop that guy, tackle him."

Enter Trey Filter and Paul Contreras. In that moment, neither hesitated to risk their safety. Trey bravely launched himself at the alleged shooter, swiftly bringing him down to the ground. Despite the suspect's attempts to flee, Contreras swiftly followed suit, subduing the suspect with Trey until help arrived. Trey's wife Casey secured the firearm, ensuring it posed no further threat until law enforcement arrived on the scene.

There were 22 people left with gunshot wounds, and one sadly died. The youngest victim was only 8 years old. Tragedies such as these, especially when conducted in a celebratory setting, speak to how precious life is and how brave it was that the Filters and Paul were willing to risk their lives for those around them.

Trey Filter, Casey Filter, and Paul Contreras are champions of Missouri. Heroes are remembered by the actions that define their best qualities, and the actions to step in and protect their community from an armed assailant is as heroic as it is selfless. I am proud to recognize their contribution to the Missouri community.●

TRIBUTE TO BRETT FORBES

Brett, an 18-year-old from St. Francois County, was born with spina bifida, but has never let his condition keep him from playing sports. Brett's siblings also share his love for athletics; his older brother Drew is an NFL offensive lineman for the Cleveland Browns, and his older sister Holly plays professional basketball overseas in Australia.

Since Brett was 6 years old he excelled at wheelchair basketball and committed to training to be a powerlifter. His hard work earned him the opportunity to compete on behalf of Team USA at the World Para Powerlifting American Open in St. Louis, MO. His performance was underscored by his 341-pound lift that broke the American rookie record. Brett did not even realize he was competing for the record, but told reporters that he was simply doing what he trained for. Brett was awarded gold and bronze medals, but his greatest achievement has been his moving story and lesson to all athletes to work hard in order to reach your goals.

Brett Forbes is truly a champion of Missouri. He demonstrates a resilient work ethic that encourages all of us to cultivate the skills and talents we possess to reach new heights. I am proud to recognize his work on the U.S. Paralympics powerlifting team and commend his parents for encouraging his and all of their children's athletic endeavors. Brett is a wonderful representative for Missouri and, more broadly, the United States on the world stage. I wish him continued success and am excited to see all this young man will accomplish in the future.●
