pend on the resources provided by the Small Business Administration.

Congress must continue to extend these resources to more parts of the country. We must ensure entrepreneurs in every community, including those in rural areas, have a fair shot at starting and growing their small businesses, and we must continue to support an environment where small businesses can succeed.
