Skills-Based Federal Contracting Act: H.R. 5235, amended, to amend title 41, United States Code, to prohibit minimum educational requirements for proposed contractor personnel in certain contract solicitations. **Pages H2247–48**

The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Energy and Commerce or their respective designees. The rule provides one motion to recommit. The rule further provides for consideration of H.R. 4758, the “Homeowner Energy Freedom Act”, under a closed rule. The rule waives all points of order against consideration of the bill. The rule provides that the bill shall be considered as read. The rule waives all points of order against provisions in the bill. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Energy and Commerce or their respective designees. Finally, the rule provides one motion to recommit. Testimony was heard from Representatives Weber of Texas and Castor of Florida.
